		Ron Solano/ Fairgrove Academy- Can chronic absenteeism still be affected by	
		Covid? As parents we do our best to not expose other students and staff to illness	
		but then students are tagged as being chronically absent.	
		<i>Response:</i> Yes, the district still had Covid protocols in place. We do not want	
		students at school if they are sick with covid, the flu or other illnesses. The district	







is asking parents to try to schedule doctor appointments after school or not to go on an extended vacation.
Lizeth Rivera/ La Puente HS: Recommend to have a 3- year comparison chart of the data so it aligns to the 3-year LCAP cycle. <i>Response</i> : This data not only informs that state how we are doing but these are some of the measures that are used by federal government. It's a great point to see what is being successful and what revisions will be needed in regards to the LCAP.
Misko Beaudrie/ Los Altos El: Why is there a performance level in Suspension Rate for Pacific Islander, meaning there are at least 30 students in that category. <i>Response</i> : For Suspension Rate, all students from Kinder- 12 th grade are counted whereas in English Language Arts it only includes the students who took the CAASPP which are grades 3-8 and grade 11.
Ron Solano/ Fairgrove Academy: What are reasons for suspensions? <i>Response:</i> There is Ed Code available that lists reasons. Some examples can be smoking, drugs, could be an item brought such as a knife or a fight depending on the severity.
Julie Zamarripa/ Sparks El and Fairgrove Academy: Where can we find the Ed Code for suspensions? <i>Response:</i> It can be found on the California Department of Education website and also there is information in the District Annual Information Handbook.
Juan Ramirez/ Cedarlane Academy: Can you give more information about Youth Court? <i>Response:</i> Yes, it would be great if we can have more information about Youth Court and the restorative practices that our district has in place for our students. We can reach out to Student and Family Services department to share more information possibly at an upcoming DAC meeting.
Ms. Risco then introduced Mr. Jeffrey De La Torre, Board Member who was on Zoom. Mr. De La Torre thanked all the parents for their time. He acknowledged the questions and discussions regarding suspensions. He referenced Senate Bill 274 that will go into effect July 1 st . Senate Bill 274 states students cannot be suspended for being defiant.
Ms. Risco then continued her presentation regarding the California Dashboard and how it is linked to the LCAP. It is required that the district use data from the Dashboard to inform LCAP development. For the 2024-2027 LCAP, any student groups that are in the red need to be addressed along with identifying performance gaps.
Ms. Risco described the three LCAP goals: Conditions of Learning that includes highly qualified teachers and maintain and improve facilities: Pupil Outcomes which includes student achievement, and







		 reducing class size; Engagement for both parents and students as well as school climate. LCAP Educational Partners Engagement Activity: DAC members formed small groups and provided input for LCAP development by addressing the questions from each chart. The groups rotated through each of the four stations. Participants on Zoom were also given the opportunity to provide feedback on the same prompts in CHAT. The input from both Zoom and in person will be shared at the March 5th DAC meeting. Ms. Risco introduced, Ms. Christine Salazar, Board President. Ms. Salazar
		thanked the parents for their time, being part of the process and giving feedback.
4.0	Guest Presenter: Community Schools	Ms. Martha Calderon, Director of Equity and Access, Family Engagement. The department has grown over the years and currently has 12 counselors designated at the elementary level, a counselor that is designated for foster students and another one to work with the homeless students.
		The department works with the community and bringing in resources for the students and families. This also includes professional development for teachers and workshops for parents. Currently, there are 18 schools in the district that are in the process of applying for a grant for Community Schools. Ms. Calderon shared a short video regarding Community Schools. <i>Video for information on Community Schools: <u>https://www.nea.org/student-success/great-public-schools/community-schools/what-are-they</u>.</i>
		 There are four pillars that help make a community school succeed. Ms. Calderon gave examples of each of the following: Integrated Student Support Active Family and community engagement Expanded and enriched learning time and opportunities Collaborative Leadership and shared decision making
		There have been surveys and meetings at the 18 schools to receive input from each school's community. Ms. Calderon gave examples of the funds that a school may receive if they are awarded the Community Schools grant. She also explained how the district will support the initiative since the grant is a 5- year grant and it needs to be a sustained initiative after the 5 years.
		Chanel Lara/ Palm EL: Are there any cons to receiving a grant? <i>Response</i> : Every grant ends so the challenge is how do we sustain the program and the coordinator at each of those sites.
		Marissa Kovall/ Newton MS: Shouldn't the district already be providing this to all our schools? <i>Response</i> : The grant provides access to have a dedicated person, a coordinator, at the site that is focused solely on Community Schools and with a focus on shared decision making to ensure that all educational partners have a voice. Mr. Fernando Sanchez also mentioned how each school has specific needs that
		will be addressed. Each school creates their own community school based on those needs.

		Renee Ventura/ Workman HS: Where are the grants from? Does the district have to put their share in as well? Does each school that receives the grant have their own coordinator or is it just one coordinator that will oversee all of the schools that receive the grant? <i>Response:</i> Grant is from the California Department of Education. Yes, part of the application process is the district agreeing to an in-kind match. This means that the district will provide funds and/or services, resources, and personnel as well. Each school that is awarded the grant will have their own dedicated coordinator. Ms. Calderon then gave more examples on the definition of homeless students. She mentioned living in a trailer without access to running water, living in a hotel/motel, living in their car, etc. She referred to the McKinney Vento questionnaire that families fill out and how the department assists these families.

The field would be used for football, band and other activities and clubs. It can be used for community events and can make revenue. Parents are concerned that this has been going on for ten years. Students and residents are witnessing people under the influence and are being affected by this situation. How can we make sure that our district families get help if they qualify as being homeless?
