- D. Possess current Certification of Clinical Competence in Speech-Language Pathology (CCC-SLP)
- E. One year of successful experience as a Speech Pathologist
- F. Able to assess and document student progress
- G. Professional in personal conduct and actions
- H. Excellent communication skills
- I. Meets federal *Every Child Succeeds* requirements

- A. Knowledge of federal and state education laws and other legal aspects of the role of the Speech Pathologist as well as the ethical standards required
