Enrollment Acknowledgement

- I understand my student must be registered, is subject to all District registration/enrollment criteria, and this declaration must be submitted to the school of residence 30 days prior to the start of the semester in order to participate. For questions regarding registration/enrollment, please contact the schools registrar.
- I understand my student must maintain enrollment in one course per semester to remain eligible for athletics per Georgia High School Association (GHSA). My student may not earn more than 2.0 credits per semester. If a student earns 2.5 credits in a semester, they are considered a full time student.
- I understand my student must adhere to the attendance requirements for the course and follow all FCS policies regarding attendance. I further understand that failure to maintain attendance requirements may result in loss of eligibility to participate in athletics.
- I understand my student must meet the same eligibility requirements as the full-time public school students (accumulated units, units passed previous semester, etc.).
- I understand that my student must reside in the attendance area of his/her custodial parent's primary residence.
- I understand my student is not eligible for a FCS Transfer Hardship of any kind and can only participate at the designated home school.
- I understand my student must follow the FCS Code of Conduct and adhere to the FCS Athletic Handbook. I further understand that my student is subject to all disciplinary sanctions pursuant to the FCS Code of Conduct which can include expulsion from their enrolled course and removal from their athletic team resulting in a loss of athletic eligibility.
- I understand that withdrawal of my student from FCS to home school full-time, will result in the loss of eligibility for one calendar year.
- I understand my student is only permitted on campus of their enrolled school during time periods relevant to participation in an enrolled class and/or participation in their athletic team.
- I understand it is at the discretion of the School Principal whether my student is permitted to participate in school-wide athletic social activities such as pep rallies.
- I understand that my student will not participate in the Fulton County Schools graduation.
