ABOUT US

The Family Health Center at College Park | College Park School-Based Health Center is a partnership between Fulton County Schools, College Park Elementary School & The Family Health Centers of Georgia, Inc. (FHCGA). The center integrates primary medical and behavioral healthcare for eligible students and affiliates in a safe nurturing place without the barriers that families often face.

ACCESS TO CARE

Teachers and students attending College Park Elementary are eligible to receive services.

The school's health professionals perform health assessments and triage of care, serve as the liaison between the student and the school-based health center staff and make referrals to the school-based health center. The school's health professionals continue to provide minor first aid and day to day asthma, diabetes or other chronic disease monitoring.

FHCGA's registration form for each patient must be completed to receive services. Parents/legal guardians are encouraged to have completed FHCGA forms on file with the school-based health center, regardless of the student's primary care physician. Parents do not need to be present for services. Parents are notified before and after each visit. *Forms are available at the school district's website, www.fhcgga.org, participating school's administrative offices, and the school-based health center.*

AFFORDABLE CARE

The cost of care is equal to, and many cases much lower than, other primary care physicians. FHCGA bills for services just like any other medical provider. Medicaid, PeachCare for Kids™ and most major insurance plans are accepted. Students without insurance may be eligible to participate in FHCGA's Sliding Fee Scale Program. *For more information regarding payment, visit www.fhcgga.org or call the school-based health center.*
