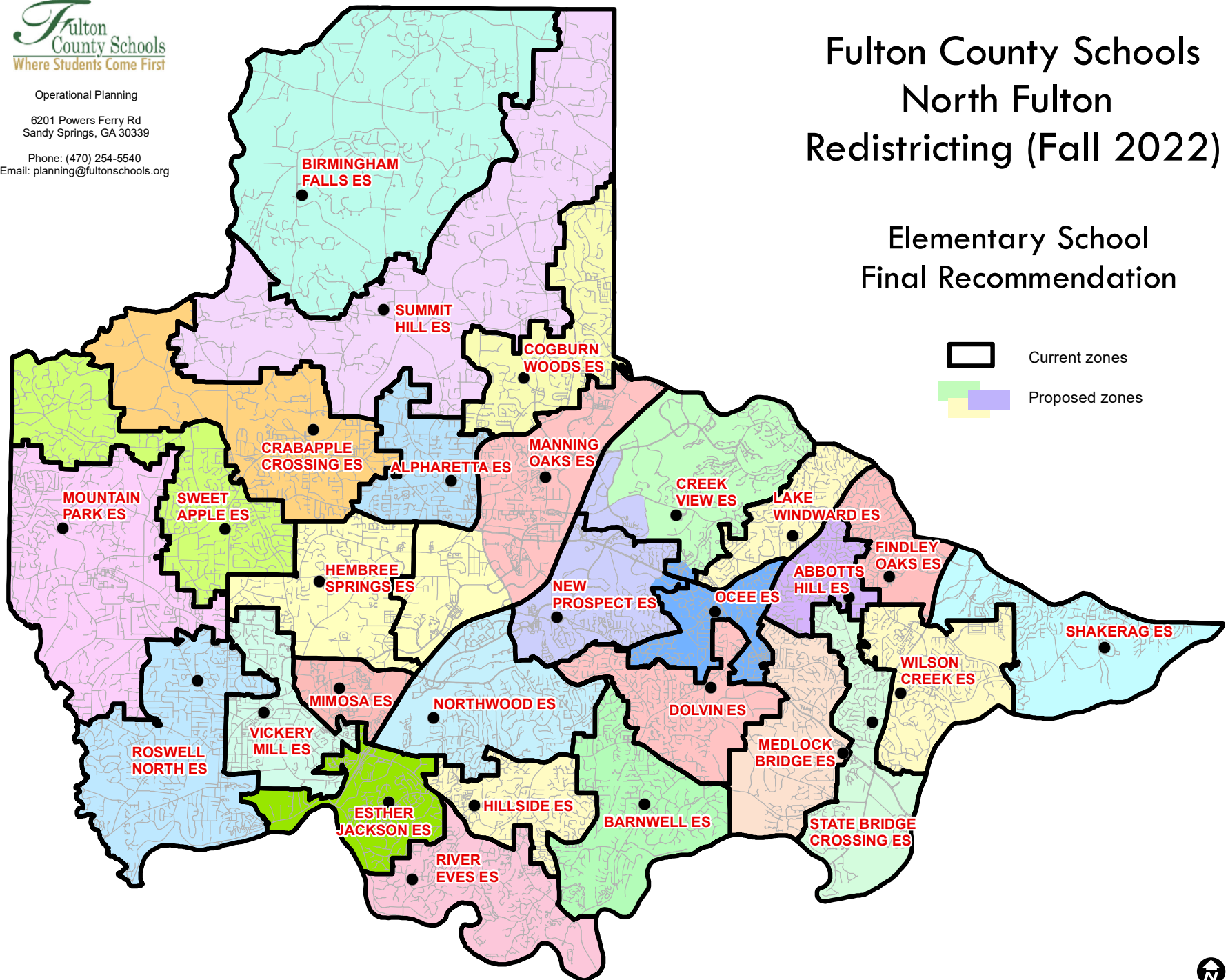

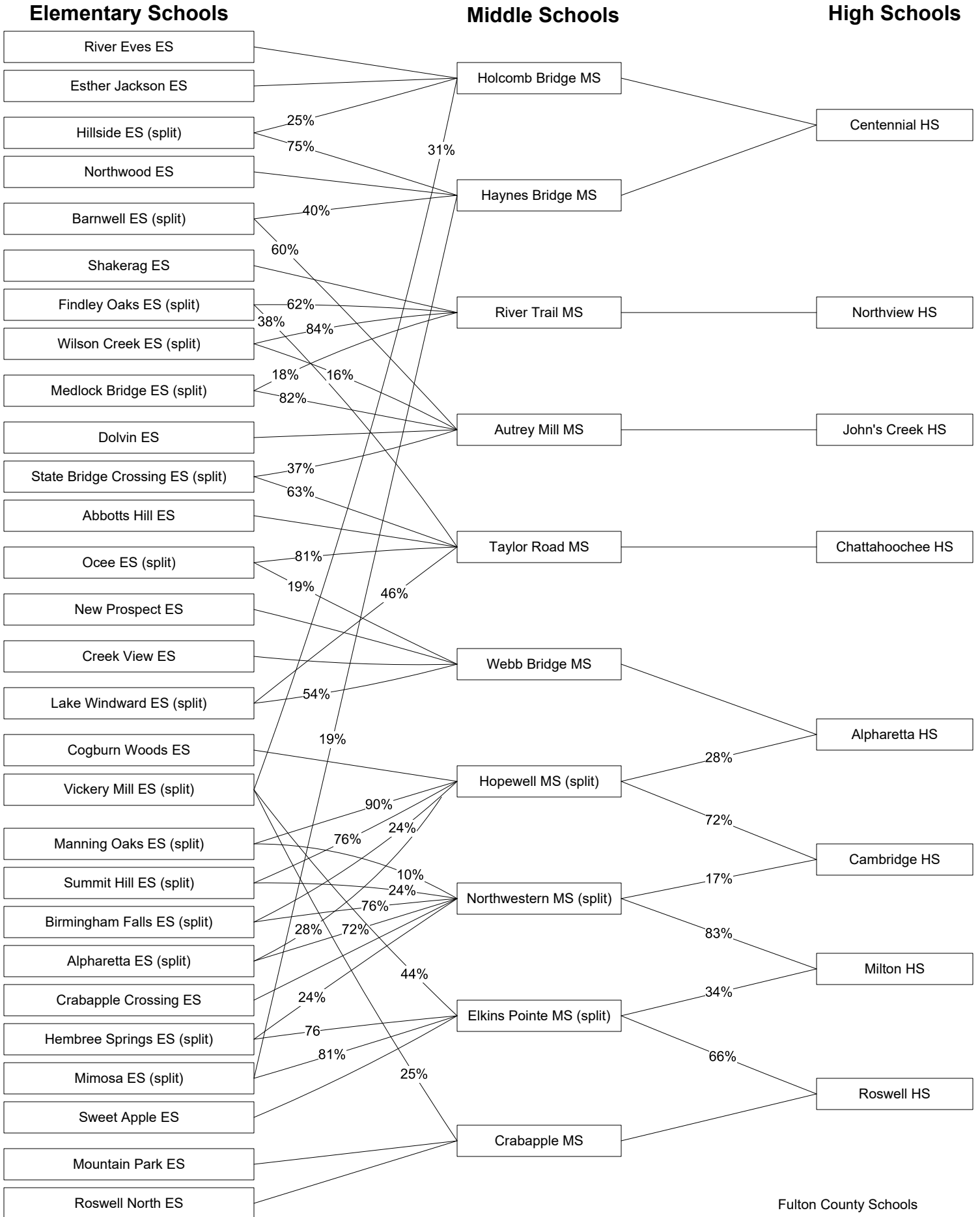

NORTH FULTON FEEDER PATTERNS 2023-24 (FINAL RECOMMENDATION)



Below is a summary of areas moved under the Final Recommendation. It does not include all streets and complexes. Please review the map for further clarification.

The Final Recommendation impacts the following elementary school zones: Creekview ES, New Prospect ES, Ocee ES, Manning Oaks ES and Hembree Springs ES

Creekview ES to New Prospect ES:

- Areas along North Point Pkwy south of Webb Bridge Rd including but not limited to IMT Alpharetta
- All areas west of North Point Pkwy between Webb Bridge Rd and Windward Pkwy including Village Park, Windward Park and Caravelle at Windward Park

Creekview ES to Ocee ES:

- Areas that immediately empty onto Webb Bridge Rd including Belmont at Park Bridge and areas along Park Woods Circle.

New Prospect to Ocee ES:

- Areas south along Old Milton Pkwy east of Brookside Pkwy including along Alexander Drive

Manning Oaks ES to Hembree Springs ES:

- Areas west of Haynes Bridge Road including but not limited to Alpha Park, Westwood Park, Westside Commons, Westside Villas, Harlow East, The Maxwell, Villa Magnolia, Vantage Point, Emblem Alpharetta, Encore Overture, Echo at North Point Center and The Artisan

The Final Recommendation does not impact any middle or high schools in the North Fulton region.
