Long Term Facilities Planning Committee: Mr. Anderson shared that the committee met on January 4, 2024, at 5:00 p.m. The committee reviewed the monies in place in the Capital Project Funds as well as the various projects that are underway in the district. The Committee also reviewed what projects they would be looking at in the next three years. Additionally, conversation was held on an enrollment study the district would like to have done and what an elementary school would like in the district.

**Policy Committee: Ms. Hatcher reminded** everyone that the next meeting will be February 6, 2024, at 5:30 pm.

Capital Area Intermediate Unit (CAIU): Mrs. Hill has completed her orientation and attended their board meeting. CAIU conducted a first read of their 2024-2025 budget which reflects no increase for the district. Mrs. Hill also reported that she will be serving on the Champions for Children Committee at the CAIU.

**Legislative Updates: Mr. Kalonji Johnson** shared that the Governor would release his budget tomorrow which includes landmark legislation for education funding. PSBA will be featuring a webinar on February 9, 2024, to provide an update on the budget proposal and what it could mean for school districts.

Superintendent's Report: Dr. Tamara Willis shared that she lent her voice to an article in Time Magazine. The Carnegie Foundation teamed up with Educational Testing Services (ETS) to reimagine what assessments should look like for students. The article mentioned Susquehanna Township School District for our work in Competency-Based Learning. Dr. Willis also shared that the Girls Basketball Team won the Mid Penn Capital Division and gave a shout out to the team and coaching staff.

Mr. Rawls added that Dr. Willis was the only Superintendent in the state to be quoted in the Time Magazine article.
