COMMUNICATIONS

ANNUAL TITLE I MEETING

Morton Elementary School will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all families of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the families' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

Morton Elementary School will hold an annual meeting during the fall Open House to:

- Inform parents and families about the school's facilities and its Title I Schoolwide designation.
- Inform families of the requirements of Title I and Morton Elementary participation.
- Provide parents/families with information regarding upcoming opportunities to participate in school and district events.
- Inform parents of Morton Elementary Reading Enrichment program, as well as provide sample instructional materials for parents to view.
- Distribute Title I, Your Child, and You informational booklet.
- Distribute parent resources with a variety of strategies that can be implemented at home.
- A video with the information shared at the annual meeting will be posted on Morton's website for parents who were unable to attend the face-to-face event.

COORDINATING AND INTEGRATING PARENT INVOLVEMENT

Morton Elementary coordinates our programs and activities with the following programs to support parent and family participation in the education of their children to include those with Limited English Proficiency and families of Students with Disabilities.

- Parents will be invited to participate on school committees.
- Exceptional Children's department provides Spanish versions of all forms and documents.
- Parent communication to ELL will be provided in a format, and to the extent practicable, in a language the parents can understand.
- Opportunities for regular public meetings.
- Annual Fall Meeting and Annual Spring meetings will be held at Morton Elementary.

The Annual Spring Meeting will be held in conjunction with another family event.

- To evaluate and/or make improvements on current program or upcoming activities.
- To solicit input from parents and families in the design and implementation of the School Improvement Plan and Parent and Family Engagement Policy for the upcoming year.
- To share overall preliminary EOG results, if available, and alert parents and families that individual reports, if available, will be sent home at the end of year in report cards.

Regular Title I Parent Meetings:

Title I Parent Meetings will be held during the school year, usually at night, to provide continued information, support and resources for all parents and families. Examples include Literacy Night, Steam Night, Family Night and Informational Sessions focusing on how to support your child at home. Flexible times will be offered.

Parents and families will be strongly encouraged to attend other school events and conferences, volunteer in classroom activities, and observe in the Title I program.

Training Opportunities:

Training topics are determined by our need's assessment data and parent and family suggestions. Meetings will be scheduled on a regular basis.

- Events will each be held during the year between the Annual Fall Meeting and Annual Spring meeting
 dates to explain state standards in curriculum and recent assessments, provide strategies to improve
 student achievement, and explain ways to monitor student progress, such as weekly folders, progress
 reports, report cards, phone communication, and conferences.
- Parents and families will be notified in advance of the scheduled activities.
- Parents and families may request additional meetings with staff members to address questions or comments.
- Instructional plans and assessment information will also be communicated to parents and families through newsletters, weekly planners, and teacher websites.

COORDINATION WITH OTHER PROGRAMS

We will meet our goals of establishing liaisons and maintaining communication with other school programs and other related external agencies and organizations through collaboration and coordination with individuals in those groups and through the following actions:

- Notifying parents and families of assistance from outside agencies, such as food banks, Salvation Army, church programs for assistance, recreation/sports/arts opportunities, Boy and Girl Scouts, Toys for Tots, the public library and summer programs.
- Inviting participation by adults from the community into school assemblies and programs with notification via flyers and social media.
- Enabling distribution of food donated by local churches that fill backpacks.
- Supporting participation in school events sponsored by library/media center, art, music, and physical education teachers at our school.
- Hosting Clinical Teacher Interns and Clinical Nursing students from East Carolina University and The University of North Carolina at Wilmington, as available, in our classrooms and school to help prepare them as highly qualified teachers.
- Partnering with the 2nd Supply Battalion at Camp Lejeune as they have adopted Morton Elementary.
- Supporting the work of the Military Life Counselor.

Opportunities for LEP and SWD Parents

Once a need is identified, we will attempt to assist parents and families with limited English proficiency and parents and families with disabilities in the opportunity to participate in their children's educational curriculum and environment.

- Translators provided as needed.
- The EC Department provides Spanish versions of the Parents Rights and Responsibilities Handbook.
