(1) <u>ENROLLMENT</u>: All enrollments are contracted for the <u>2016</u> ESY program and are subject to the terms and conditions herein set forth.

To pay to the School for the care, maintenance, support and education of the Student, the Educational fee of \$219.44 per diem for 20 days and the Residential fee of \$146.08 per diem for 28 days for a total of \$8,479.04 for the weeks of JUNE 23 TO JULY 20, 2016.

The non-payment of any overdue account gives the School the right to refuse to consider attendance and participation in the ESY program.
