

Contract made on \_\_\_\_\_ between the Township of Carroll, a municipal corporation duly organized and existing under the laws of the Commonwealth of Pennsylvania, located in York County, Pennsylvania, hereinafter called "**TOWNSHIP**" and Northern York County School District organization operating under the laws of the Commonwealth of Pennsylvania, whose principal place of business is located at Dillsburg, Pennsylvania, of York County Pennsylvania, hereinafter called "**DISTRICT.**"

In consideration of the mutual covenants contained herein, the Township and District agree as follows:

**SECTION ONE**

FURNISHING POLICE UNITS OR OFFICERS

The township shall furnish the District private police security service consisting of uniformed police officer, or more as may be agreed upon from time to time between the parties to protect the District property, as well as patrol units as needed. The police may make suggestion to relieve hazards that are found to exist, and to provide other forms of police protection for the safety and welfare of those on the premises of the District.

**SECTION TWO**

SUPERVISION OF POLICE OFFICERS

The supervision of the police officers will be the responsibility of the Township, and the police officers shall be under the immediate supervision of the Chief of Police of the Township.

**SECTION THREE**

FURNISHING OF BENEFITS

The Township shall pay social security benefits, state workmen's insurance and professional police liability insurance for the police officers.

**SECTION FOUR**

METHOD OF PROTECTION

All police officers who come under the terms of this agreement will carry out the function of protecting the premises of the District in the manner best suited, depending on the circumstances. It is further understood that services, which come under the terms of this contract will be furnished during such hours agreed on by the parties hereto.

**SECTION FIVE**

TIME FOR PERFORMANCE

The District will give the Township sufficient time after acceptance of this contract to arrange intelligently the force to be detailed and be assured that each police officer and unit be outfitted so that their appearance will reflect favorably to both parties of the agreement.

**SECTION SIX**

WAGES OF UNIT AND OFFICERS

For the services to be rendered under the terms of this contract, the District agrees to pay the following sum per hour, per officer, including the unit:

July 1, 2016 through December 31, 2016...\$80.00 per hour

January 1, 2017 through December 31, 2017...\$83.00 per hour

January 1, 2018 through December 31, 2018...\$85.00 per hour

Payment by the District shall be made directly to the Township. Further, it is understood that the Township shall in turn pay the officers for their time under the police contract between the Township and the police officers.

**SECTION SEVEN**

TERMS OF AGREEMENT

The above services will begin on August 10, 2016 at 0001 hours, (a.m.) This contract shall be for a three (3) year term and shall expire on December 31, 2018. At the expiration of the initial term, this agreement shall continue in force until either one of the parties gives thirty (30) days written notice to the other that it is terminating this agreement.
