This agreement ("Agreement") is made by and between the Commonwealth of Pennsylvania ("Commonwealth"), through its Pennsylvania Department of Education ("Department"), and Northern York County SD located at 650 S Baltimore St. Dillsburg, PA 17019, ("Grantee").

The Department, created by Section 201 of the Administrative Code of 1929, as amended, 71 P.S. § 61, is the State Education Agency responsible for administration of grant programs pursuant to the General Appropriation Acts and the Public School Code of 1949, as amended, 24 P.S. § 1-101 et seq. and has been awarded funds by the US Department of Education for Elementary and Secondary Emergency Relief (ESSER II) programs under the, P.L. 116-136. Coronavirus Response and Relief Supplemental Appropriations (CRRSA) Act, Public Law 116-260.

The parties, intending to be legally bound, agree as follows:

- 1. Pursuant to this Agreement, Grantee will receive funds in the amount of \$1,157,448.00. The grant shall be used to defray program costs incurred from March 13, 2020 to September 30, 2023.
- 2. The Agreement shall become effective on the date it is fully executed by all required parties and shall terminate on September 30, 2023, unless terminated earlier in accordance with the terms hereof.

INTRODUCTION

Under the Elementary and Secondary School Emergency Relief II Fund (ESSER II), authorized by the Coronavirus Response and Relief Supplemental Appropriations (CRRSA) Act, the Pennsylvania Department of Education (PDE) awards grants to School Districts and Charter Schools to address the impact that Novel Coronavirus Disease 2019 (COVID-19) has had, and continues to have, on elementary and secondary schools across the state.

Please note: ESSER II funds **cannot** be used for: 1) subsidizing or offsetting executive salaries and benefits of individuals who are not employees of the LEAs, or 2) expenditures related to state or local teacher or faculty unions or associations. The Northern York County School District completed a Health and Safety Plan on July 28, 2020. This plan has since been revised on August 25, 2020 and March 23, 2021. This plan, approved by the Board of School Directors, addresses the mitigation efforts of the District and the flexibility needed to provide instruction to the students of the District under varying methods of instruction due to the COVID-19 pandemic. This plan outlines a variety of standards that address considerations given to health and safety. The largest area of consideration was the need to provide instruction to students in a virtual model. As such, the District planned to simultaneously offer multiple tiers of instruction that provides several options for family choice. These options include face-to-face instruction, a full online with remote instruction and asynchronous lessons, and full virtual option. The greatest needs are related to securing the appropriate staff, licenses, and equipment to provide the varied instructional models.

Please explain the LEA(s) proposed timeline for providing services and assistance to students and staff. (3000 characters max)

The District will be providing virtual options to all students at every grade level throughout the 2020-2021 school year. These options began on the first day of school, September 8, 2020 and will continue through the final student instructional day scheduled for June 8, 2021.

The District plans on using ESSER II funds to promote the fully online remote instruction with asynchronous lessons. ESSER II funds will be used to purchase the online instructional model chosen by the District as well as the instructional staffing costs associated with offering this live virtual instruction.

Please describe how the LEA intends to assess and address student learning gaps resulting from the disruption in educational services. (3000 characters max)

The District opened with a hybrid model in grades 7-12 which allowed two cohorts to be in the classroom two days a week with online instruction for the other three days a week. This hybrid model switched to a four day a week in-person instruction model in March 2021. Students in grades K-6 have had full face-to-face instruction since the start of school. Universal screeners have been used at the elementary and middle school students since the start of school in September in both literacy and mathematics. These will include a variety of standardized norm referenced measures such as AimswebPlus. The District will also conduct diagnostic measures and curriculum-based measures such as sentence dictations, sight words, i-Ready, Words Their Way screener, and Hegerty screeners at designated grade levels. Results from local benchmark and diagnostic screeners, as well as standardized assessment results for assessments such as WIDA ACESS, PASA, PSSA, and Keystone Exams will be used to identify student learning gaps. Screeners and diagnostic tools will be administered to virtual students through Zoom and online testing services to every extent possible. The District will form a Learning Loss Task Force, which will include stakeholders from each level, to review assessment and survey data to determine how best to provide services and programs targeted to high-need students.

Please describe the LEA(s) proposed procedures for evaluating local COVID-19 impacts in relation to education programming and delivery. (3000 characters max)

Areas of emphasis should include:

- Documenting learning loss associated with extended school closure;
- Outlining the development of local continuity of education plans over the course of emergency response efforts; and
- Detailing supports for vulnerable student populations and families.

The District opened with a hybrid model in grades 7-12 which allowed two cohorts to be in the classroom two days a week with online instruction for the other three days a week. This hybrid model switched to a four day a week in-person instruction model in March 2021. Students in grades K-6 have had full face-to-face instruction since the start of school. Students with special considerations such as IEP, 504, and current ELs were provided the option of attending in-person classes four days a week in grades 7-12 since the start of school. This was for the purpose of providing additional instructional support and services to meet the individual needs of these students. Additionally, select students were provided the option of attended Friday sessions at the request of the family. The Friday sessions were limited to high-need students. Collaboration with homeless and foster students was a deliberate component of our planning to ensure that these students had the necessary resources such as devices, hotspots, connectivity, and related services to participate in either remote or faceto-face instruction. The use of universal screeners for school year 2020-2021 will provide data points related to the educational proficiency levels of students. Data teams at each building will review data points following the completion of screeners. In addition, school administrators and counselors have developed systems to monitor student online engagement, assignment completion, and daily attendance. All students, regardless of instructional model, are required

to participate and attend school daily and tracking methods are in place to ensure students are attending virtual sessions. The District plans to administer universal screeners to students receiving face-to-face instruction as well as those learning virtually. Action steps have been taken to pre-load the assessment software as well as provide secure test tickets for students participating in the local benchmarks remotely. Zoom will be used for any measure that require the face-to-face administration (e.g. Oral Reading Fluency). Families will also have the option to bring in their student to physical school should that be their choice.

Please describe the LEA core set of strategies that will be used to guide local investment of ESSER II funding, associated with short-range (*i.e.*, remainder of the 2020-21 school year) and long-range (2021-22 and 2022-2023 school years) timelines. (3000 characters max)

These strategies may entail the establishment, scale-up, refinement, or evaluation of remote learning, as well as strategies for school-based teaching and learning responsive to conditions related to the pandemic. LEAs will be asked to outline how limited, ESSER II funding may support these initiatives and how these funds might interact with other federal funding, including enhanced Title IV flexibility, to ensure strategic and sustainable use of funds.

Our Health and Safety Plan prioritized the multiple instructional models to provide families with choices for the 2020-2021 school year. We anticipate offering this choice in the fall of 2021 as well. The plans necessitated the creation of an elementary full time virtual academy and creating a more robust full time virtual academy for grades 6-12 due to the increased enrollment in this option. The District was already a member of the Capital Area Online Learning Association which provided the full time virtual academy for grades 6-12. While ESSER I provided some funding for this option, it did not provide enough funding to fully cover the costs of this program. ESSER II funds will help cover the total estimated costs of \$800,000 for the 2020-2021 school year. In addition, staffing changes were made in the buildings to provide additional classroom spaces to adhere to the social distancing guidelines of 6 feet. ESSER II funds will be used to offset the costs needed to provide these additional spaces.

Please describe specific plans, measures, and longer-term evaluative strategies concerning student learning gaps - as well as opportunity to learn factors - stemming from COVID-19. (3000 characters max)

Many of the traditional measures used for district, school, and individual student accountability have been disrupted by COVID-19. Our ability to evaluate student learning outcomes has been impacted by our ability to provide face-to-face instruction, virtual lessons, and effective remote assessment strategies. Our Health and Safety plan provides increased accountability for daily attendance, student engagement, live remote instruction, planned ongoing special educations services, contingency plans for students having to quarantine that keeps them engaged in the learning process, and assessment strategies. The District will employ the assessment plan moving throughout the school year benchmarking three times during the school year, progress monitoring at least monthly, and providing associated differentiated instruction to meet the needs of students. Monitoring of online/virtual lessons will be completed each week and communication with students/families will occur relating to student progress. The District will evaluate local sources of data in January and again in May as it relates to universal screeners and benchmarking. Attendance, grades, and assignment completion rates are also factors that will be tracked throughout the year. COVID-19 safety precautions have

followed and will continue to follow DOH guidance. This has created a challenge for flexible instruction groups, mixed cohorts, pull-out instruction, and on-on-one methods that we have previously utilized. MTSS And Child study teams continue to participate in at least monthly rostering meetings to identify struggling students. Weekly monitoring will occur with school counselors, instructors, and attendance secretaries to track student attendance concerns. Participation in state mandated assessment protocols (e.g. PASA, PSSA, Keystone Exams, WIDA ACCESS 2.0) will continue and the District will review the data as it becomes available.



2. TERMS OF PAYMENT:

- a. All grants are placed on a system of scheduled payments to provide operating funds during the period of the Agreement. Monthly payments are determined by dividing the approved amount by the number of months during the term of the Agreement. Payments will be initiated by the Comptroller's Office after arrival of each fully executed Agreement.
- b. Grantee shall implement a cash management system that will ensure that only the minimum amount of cash required to effectively operate the program is requested and/or kept on hand. Failure to implement and maintain such a system can result in the Grantee being suspended until an adequate cash management system has been implemented.
- c. During the life of this Agreement, unless otherwise provided in Program Guidelines, Grantee shall submit the following financial reports to the Comptroller's Office or the Department:
 - 1. Reconciliation of Cash on Hand Quarterly Report PDE Form No. 2030, and
 - Final Expenditure Report.
- d. Grantee will conform to all policies and guidelines cited in the Department's individual program Policies and Procedures and/or instructions associated with the Reconciliation of Cash on Hand Quarterly Report, and Final Expenditure Report concerning the financial reports described in Paragraph 2(c), above.
- e. The Department reserves the right to disapprove any expenditures by the Grantee that are not in accordance with this Agreement.

3. REPORTING:

Grantee shall submit any required program and or fiscal reports that are designated by the Department and/or federal awarding agencies for the purpose of determining program outcomes and compliance. Due dates and reporting requirements will be announced by the Department.

Any unexpended funds remaining at the end of the grant period must be returned to the Department of Education.

4. FUNDING LEVEL: THE TOTAL COST TO THE COMMONWEALTH UNDER THIS AGREEMENT SHALL NOT EXCEED THE AMOUNT SET FORTH IN THE AGREEMENT.

Payment of that amount <u>is contingent upon the availability of Program funds and appropriations sufficient to pay the total costs.</u> Any funds provided to the Grantee under this Agreement may only be used in accordance with this Agreement.

- a. FUNDING INCREASE If the Commonwealth determines that additional Federal or State program funds are available for use under this Agreement, the Commonwealth <u>may at its sole discretion</u> increase the approved program cost. Such increases will be made in accordance with paragraph 5 ("Funding Adjustments").
- b. DECREASE The Commonwealth reserves the right, at its sole discretion, to reduce the total cost of this

Agreement when the Federal or State funds appropriated by the U.S. Congress and/or State Legislature are less than anticipated by the Commonwealth after Execution of this Agreement hereunder; or the funds appropriated are later unavailable due to a reduction or reservation in the appropriation. Such decreases will be made in accordance with paragraph 5 ("Funding Adjustments").

- c. UNEXPENDED FUNDS Grantee understands and agrees that funds which remain unexpended at the end of the term of the Agreement or upon termination of the Agreement shall be returned to the Commonwealth within sixty (60) days of the project's ending date or termination date along with the submission of the Final Completion Report and/or Final Expenditure Report, depending on the applicable program requirements.
- d. WITHHOLDING OF FUNDING Without limitation of any other remedies to which it is entitled hereunder or at law, the Commonwealth shall have the right to withhold the funding granted under this Agreement, in whole or in part, for any of the following reasons, without limitation:
 - 1. failure of Grantee to fulfill in a timely and proper manner its obligations hereunder;
 - 2. violation of laws, regulations or polices applicable to the grant or to the implementation of the project funded under this Agreement; and
 - 3. misuse of funds, mismanagement, criminal activity or malfeasance in the implementation of this Agreement.

5. FUNDING ADJUSTMENTS:

Funding Adjustments may be made for the following reasons and in the following manner:

a. Funding Increase:

- 1. The Commonwealth shall notify the Grantee in writing of any funding increases under this Agreement.
- Upon receipt of this notice the Grantee shall revise and submit to the Commonwealth a revised Program Summary Budget and if necessary, any revised pages of the Narrative which shall reflect the increase of funds.
- 3. Funding increases will take effect upon Commonwealth's receipt and approval of the revised documents, which shall be incorporated in and made part of this Agreement.

b. Funding Decrease:

- 1. The Commonwealth shall notify the Grantee in writing of any funding decreases.
- 2. Funding decreases will be effective upon receipt by the Grantee of the Commonwealth's funding decrease notice.
- 3. Funding decrease notices shall be incorporated in and made part of this Agreement.

c. Transfer of Funds Among Cost Categories and/or Object Codes:

Any transfer of funds among cost functions and/or object codes must be made consistent with the applicable Program Guidelines.
