Ms. Carricato called the meeting to order at 6:30 P.M.

The meeting opened with the "Pledge of Allegiance to the Flag".

ANNOUNCEMENT OF EXECUTIVE SESSION

Ms. Carricato announced an Executive Session was held prior to tonight's meeting to discuss personnel.

PRESENTATIONS

Mr. Waters introduced Mr. Kevin Dolphin, founder of Breaking The Chainz, Inc. to speak about his community outreach program that focuses on at-risk youth. Mr. Dolphin provided handouts to the board members and a copy of his clearances and resume to the district. Mr. Dolphin stated he is a youth counselor in HIV/AIDs and substance abuse. He designed all the curriculum in the handouts provided. His program works through police, youth camps, detention centers and schools to direct at-risk students' social skills to correctly handle culture diversity in becoming effective citizens. This program accepts donations in order to continue providing services. A classroom for approximately an hour a week, either during the day or after school, will be needed. Ms. Woods questioned the ages in the program, Mr. Dolphin said they accept children as young as age four, depending on the curriculum. Ms. Bowman stated two of her grandchildren participated in the program, she reported witnessing firsthand the changes in the children, complimented the program on working with families as well as the children and highly recommended this program. Ms. Slade, Mr. Spizzirri, Mr. Petrovich and Mr. Lewis took part in the conversation supporting implementation of the program in the district. Mr. Waters stated the administration recommends the board give permission for the district to begin discussions with Mr. Dolphin.

Mr. Jamal Jones, Program Manager and Ms. Melanie Hinson, Youth Work Experience Coordinator presented ResCare Work Experience/Internship. They spoke on the in-school work experience program opportunities with community businesses involvement working together to train, mentor and employ high school students. This program also assists students who have not graduated to complete GED, support and offer training for future employment. Mr. Salov stated this would be an opportunity for the students who attend half day classes. Mr. Waters added this program would not be taking staff's time, the program handles everything themselves and the agreement is on next week's agenda for vote.
