- * Surveyed surrounding school districts about their practices and policies
- * Modified recommendations

Background

*Range of cumulative grade point average (GPA)
from 1.00 to 4.77 (2.00 = C average)

- *5 students < 1.50 cumulative GPA
- *23 students < 2.00 cumulative GPA

Student Achievement and Grades High School

- 1. The current requirement for participation for students in extracurricular activities (athletics) states that a student must be passing all classes to participate. Do you feel this is a fair policy? Why or why not?
- 2. What support do you think students need in order to maintain eligibility?
- 3. Do you believe this support currently exists at your school? Why or why not?
- 4. How would you react to a change in eligibility that would require students to maintain a C average?
- 5. How would you react to a change in eligibility that would require students to maintain passing grades in all classes throughout the entire school year, not just while the sports or activity is in season?

Focus Groups - April, 2012

- *Gathered 3rd quarter grades of all middle school students (6th, 7th, 8th grades)
- *Included all middle school and K-8 students that use the standard middle school report card (excludes ANLC)
- *Accumulated GPA is not done for middle school students in our data system
- *3rd quarter grades were converted to grade point average (GPA)

Additional Data Gathering and Methodology

*Total number of Middle School Students Sampled - 5066

*Total number of Middle School Students with below a 2.0 GPA - 477 - 9.4%

*Expansion of current systems to monitor student learning (Data Central, Synergy, Galileo, etc).

- *Connect current interventions and supports as a regular part of work done with students at the school level
- *Expand intervention and supports to become part of how schools respond when students fall below a 2.0 GPA

Meeting to review additional data, interventions and support, feedback from the Governing Board, modifying recommendations

AS a DISTRICT, we truly believe in our tag line, *Engage*, *Educate and Empower Every Student*, *Every Day*... this means our recommendation to the Governing Board is:

- * Establish 2.0 GPA (current GPA) as the targeted GPA <u>for all students</u> as the minimal standard for SUSD
- * Require more frequent grade checks minimum every 4.5 weeks
- * All students below a 2.0 GPA in the current marking period must participate in intervention or support systems or programs in order to maintain eligibility for participation
- * Students must fulfill the requirements of intervention or support systems to be eligible to participate in competitive events
- * Current No Pass/No Play requirements remain in place (no Fs as determined by the most recent marking period)
- * Coaches, sponsors or program directors are responsible for grade checks
- * Focus on supporting students versus punishing students
- * Implementation:
 - * 2012-13 Educate and raise awareness, design supports and interventions to mirror other initiatives throughout the District (grading committee, newly adopted materials, etc.)
 - * 2013-14 Full implementation
