PreK 3: Child must be **three-years-old** by September 1, 2024 to be considered, no exceptions.

PreK 4: Child must be **four-years-old** by September 1, 2024 to be considered, no exceptions.

## Early Childhood Program Class Options:

### Half Day Options:

**PreK 3** (Morning options only)

- 2.5 hours for 2 days
- Monday and Tuesday or Wednesday and Thursday class
- **Locations:** Dilworth (*Non-Title 1*), Edison, Liberty, Newman, Parkview & Washington Elementary Schools

**PreK 4** (Morning or Afternoon options available)

- 3 hours
- Monday, Tuesday, Wednesday, Thursday
- **Locations:** Dilworth (*Non-Title 1, PM only*), Edison (*PM only*), Liberty (*PM only*), Mountain View, Newman (*PM only*), Parkview (*PM only*), Washington (*PM only*), & Whittier Elementary Schools

**PreK 4** (Hours based on elementary bell schedule)

- Monday, Tuesday, Wednesday, Thursday
- **Locations:** Backman, Beacon Heights (*Non-Title 1*), Edison, Escalante, Franklin, Indian Hills (*Non-Title 1*), Liberty, Meadowlark, Mountain View, North Star, Parkview & Washington Elementary Schools

The Early Childhood Department reserves the right to cancel class due to lack of enrollment.

Required Documents for Registration:

- Child's **official** birth certificate
- A **non-refundable** registration fee of **\$30** (*Title 1*) or **\$85** (*Non-Title 1*) (fee amount subject to change)
- **First month's tuition** (cash, check, money order, or credit cards accepted)
  - To see if you qualify for *Title 1* reduced tuition, bring your Income Tax Return from 2023 (1040 form). Your child's name must be on the form!
