Upon obtaining the contract documents, Bidders (General / Prime Contractors) will be placed on the plan holders list. An acknowledgment on the plan holders list is mandatory for all bidders (General / Prime Contractors).

A **mandatory pre-bid** conference and walk-thru to review the project will be held at the North end of the Highland Football Field, 1800 Bench Road, Pocatello, Idaho, on March 20, 2024, at 10:00 AM.

Each bid shall be accompanied by a certified check, cashier’s check, or a bidder’s bond, (executed by a qualified surety company with the power to do business in the State of Idaho) in the sum of not less than five percent, (5%) of the total bid, made payable to Pocatello/Chubbuck School District No. 25, Bannock County, Pocatello, Idaho. This surety shall be forfeited by the bidder in the event of failure to enter into a contract. Personal or company checks will not be accepted. Compliance with Idaho Public Works Law is required.

All bids must be on the forms furnished, all blank spaces filled in, and signed with the name and address of the bidder and placed in a sealed envelope and clearly marked: **Highland High School Athletic Facility**; Opened at 9:00 am MST on March 28, 2024. No unqualified bids will be read.
