

Mary Lipkin Scholarship Guidelines

Eligibility:

- High school senior graduating from Midland High School.
- Attend Midland High School for at least junior and senior years.
- Upper 25% of class at the end of 7th semester and maintained through 8th semester.
- Enrollment in any school or institution on the approved list of schools as published by the Illinois State Scholarship commission, or an equivalent out-of-state school as listed by the Guaranteed Student Loan Program for at least 12 semester hours each semester.
- Completed application to Midland Unit No. 7 guidance office by April 5.

Length of Scholarship:

- The scholarship will be in effect for one year for a total of \$300.00.
- The scholarship will be revoked if the student is placed on probationary status after the first semester.

Maintaining Scholarship:

- Transcript sent to Midland Unit No. 7 at the end of the first semester.
- Maintain grades to remain on no probationary status each semester.
- Enrollment in at least 12 semester hours for each semester.

Criteria for Selection in Order of Importance:

- Financial need.
- Academics.
- School activities.
- In the event of more than one candidate, a personal interview may be conducted.

Payment of Scholarship:

- Payment of the amount of \$300.00 will be sent directly to the student in January when the student furnishes a transcript for the first semester and proof of enrollment for at least 12 semester hours for the second semester.
