8:04	Informational Item: Principal's Update -thank you, teachers – URL going well -surveys for Phase I went out to preK-2 nd families, received 350 responses out of about 600 families, 75 have opted for face to face -Phase I will be face to face - 1 90-minute session per week (180-minute session for MOID), there will be no more than 4 students in a classroom at one time, all students will be required to wear masks, snack and transportation will be provided, goal of Phase I is to acclimate students back to the classroom -goal is for everyone to be safe – keep wearing masks and social distancing - Fulton County will continue to monitor COVID-19 cases to determine the pace of moving through the phases, it is likely that if the data shows a positive trend of decreasing cases and all goes well in the previous phase, we will move through the phases of returning F2F quickly -the closing matrix will be utilized depending on spread -Fulton County has been reporting cases on the FCS website, COVID page	Mrs. McGee
