7:34	<b>Informational Item: Principal's Update</b> <ul style="list-style-type: none"> <li>- CCRPI information: Score 86.3 (increase from last year). Way CCRPI was designed was to be slow and steady, not go up and down. What you scored this year means your target scores change next year. Four areas schools are rated on: Content Mastery, Progress, Closing Gaps, Readiness. Of those 4 categories, progress weighs the most. We need to continue to improve in the area of progress. In content mastery, we increased our scores to 88.8. In progress, we went down to 81.0, particularly in math. The math coach is continuing to work with teachers to help close the gaps, particularly students working on high-demand tasks when they are not with the teacher. They are also working on real-world problems. Closing gaps increased to 92.9. Readiness increased to 87.0. Ms. McGee shared the GaDOE CCRPI website and went through the scores with the SGC. The score does not represent all of the extra programs we do: STEM, Design Thinking, coding, robotics, culinary arts program. School Climate – 5 star school!!! Financial Efficiency – haven't received score yet in this area.</li> </ul>	Mrs. McGee
