## A FOCUS ON ACADEMIC EXCELLENCE, CLASS SIZE AND STUDENT WELLNESS

Dear Ardsley Union Free School District (AUFSD) Residents, It has been a unique year for our school district. Overall enrollment in grades 1-12 increased by 84 students and kindergarten enrollment increased by 31 students from the prior school year, four additional faculty positions were added to our staff, 339 new homes were built within our school district, and two new members joined our Board of Education. Our students enjoyed great success with several receiving regional and national academic awards and competing in international competitions. Many of our athletic teams also successfully competed at the regional and state levels.

As we look ahead to next year, you will be voting on a school budget to support our increased enrollment and the goals we have established for the district. The recent growth in student enrollment, fueled by the record number of new housing developments, presents our taxpayers with a unique set of circumstances.

AUFSD student population has grown by 203 students over the last five years More teachers, classrooms and sections are required to ensure class sizes and maximize learning

New housing developments have added 339 new homes to our district More people are paying school district taxes

Total assessed value in AUFSD has gone up due to both new properties and changes in assessment For the FIRST TIME in recent history the tax rate for each homeowner will go DOWN .49% from \$22.54 to \$22.43 per \$1,000 assessed value

We are proposing a year-to-year budget increase of 3.39% which will reduce class sizes in all schools and allow us to increase our focus on social and emotional wellness resources and programs.

Because of the unique situation of the tax rate going down, we are able to propose a tax levy of 4.7% that falls <u>BELOW</u> the allowable tax levy cap of 5.15%.

**THE TAX RATE IS GOING DOWN AND THE PROPOSED BUDGET IS BELOW THE TAX CAP.** This year's maximum allowable Tax Levy Cap based on the New York State formula is 5.15%. The Board of Education has determined that we can reduce this rate to 4.7%. This will minimize the tax impact on our residents while funding a proposed budget that includes seven new full time positions across all three schools, plus additional part-time staffing in our middle and high schools.

Since the total taxable assessed value in AUFSD has gone up due to the record breaking number of new homes contributing to our revenue and the town's recent reassessments, the tax rate for homeowners has come DOWN for the first time in recent history.

For this reason, a 4.7% Tax Levy <u>DOES NOT</u> mean a 4.7% increase in your school taxes. Why? The estimated tax rate of \$22.43 per \$1000 of assessed value is actually .49% less than last year. It is this tax rate which is used to calculate what each property owner will pay in school taxes. This reduced tax rate will be applied to the assessed value of your home.

**WE THANK YOU, OUR COMMUNITY!** As part of our search effort to replace Dr. Allan, we fielded a survey that asked the community to identify challenges facing the district and we thank you for responding. You told us that managing class sizes, maximizing learning opportunities for all our students, and increasing the focus on our students' social and emotional wellness are priorities for our community. This budget supports these needs for the coming school year. We will continue to explore additional district priorities as we finalize our next strategic plan with our new superintendent.

We thank you for your continued support of the district and wish everyone a successful end to the school year.

## FREQUENTLY ASKED QUESTIONS:

**HOW DOES THIS BUDGET ADDRESS THE CHALLENGES OF INCREASED ENROLLMENT?** Resources are being ADDED in all three schools:

- Concord Road Elementary School: two full-time teachers, one special education teacher, one psychologist shared with AMS, additional sections in physical education, science, and art, and equipping two new classrooms;
- Ardsley Middle School: two full-time teachers for fifth and sixth grades, one special education teacher, and one psychologist shared with CRS;
- Ardsley High School: additional sections in English, science and social studies to manage class sizes.

**SINCE THE TAX RATE IS LESS THAN LAST YEAR, WILL MY TAXES ALSO BE LESS?** It depends on the result of the Town of Greenburgh's reassessment of your property. Your individual taxes are calculated by multiplying the value of your property by the tax rate (\$22.43 per \$1000 of assessed value).

WHAT WILL HAPPEN IF THE COMMUNITY DOES NOT APPROVE THE SCHOOL BUDGET ON MAY 15<sup>TH</sup> WITH A SIMPLE MAJORITY VOTE? State law provides that the Board of Education can re-submit the same or a different budget to the community for approval one more time by funding a second vote. If the second budget is also rejected or if the Board of Education decides not to re-submit the budget for a second vote, the school will operate on a contingency budget.

This budget proposes the addition of seven full-time positions across our schools. It also addresses class size concerns by adding sections in various subjects in the middle and high schools. A contingency budget would eliminate all of these additions.

#### **SHARING SUCCESSES**

- Three students were selected as semi-finalists in the **Siemens Competition** and one placed second in the national finals;
- Two students were selected as scholars in the **Regeneron Science Talent Search**;
- Seventy-seven AHS juniors were inducted into the National Honor Society;
- **AMS Math Counts** team placed second at the regional competition and eighth in the states;
- AMS Science Olympiad teams won medals in the regional tournament;
- Twenty-eight participants from AHS attended the National High School Model United Nations Conference;
- AHS DECA club members earned over twenty-five top place medals and six trophies at the state level;
- AHS Science Olympiad placed first at the Lower Hudson Regional and went onto the states;
- AHS math team finished in the top ten in the Westchester-Putnam Interscholastic Mathematics League;
- AHS Science Research program competed at WESEF earning eight medals. Two students were advanced to the Intel International Science Fair;
- Over thirty students' **artwork** was shown at Pace University, the Atria Woodlands, Concordia College, and the Katonah Museum;
- Over forty students from all three schools have participated in NYSSMA All-State Band, Orchestra and Chorus Festivals;
- Two AHS students earned Gold and Silver Key Awards in Journalism and Poetry respectively in the **Scholastic Writing Competition**;
- AHS Select Chorus sang at the Cathedral of Saint John the Divine and at Rockefeller Plaza;
- Our **AHS Varsity Basketball** team "shocked the section" and competed in the state finals.

# THE BUDGET VOTE IN Plain English

The proposed budget:

- Reduces class sizes in all buildings;
- Increases funding for programs and staff to support our students social and emotional wellness;
- Maintains all current programs and offerings;
- Preserves a fiscally responsible fund balance for our District's future.

The budget proposes a tax levy **below** the Tax Levy Cap.

Your taxes are determined by the tax rate, which is going down for the first time in recent history. The tax rate of \$22.43 per \$1000 of assessed value is .49% less than last year.

#### **VOTER ELIGIBILITY AND ABSENTEE BALLOTS**

In order to vote, you must be a registered voter who is at least 18 years of age, a citizen of the US and a resident of the Ardsley School District for a period of 30 days or more prior to the election date. If you are not available to vote in person, you can complete an absentee ballot application by coming to the District Office between 8:00 a.m. and 4:00 p.m., Monday – Friday, or by downloading a copy from our website (<u>www.ardsleyschools.org</u>). In order for your absentee ballot to be counted, it must <u>be received</u> by the Office of the District Clerk by 5:00 p.m. on May 15<sup>th</sup>, so please account for mailing time or bring it to the District Office in person.
