## CAPITAL Improvement Bond Proposal in Plain English

Will you allow the district to replace a current bond and spend up to \$20 million with no additional costs to taxpayers? This replacement bond would allow us to install alternative energy systems to reduce costs, to expand and update our STEM classrooms and equipment, to preserve our facilities and to increase safety, as well as several other interior projects.

#### ✤ CAPITAL IMPROVEMENT BOND PROPOSAL:

The Ardsley Board of Education and the District's administration are committed to providing facilities that are high quality, safe, and create an environment conducive to learning. In order to support the high standards for teaching and learning set forth in our strategic plan and to expand STEM curriculum in all three schools, we need to redesign classroom workspaces and provide the technical equipment necessary for advanced learning. Much like we maintain our homes, we must continue to preserve and maintain our facilities and update portions of our infrastructure such as roofs, elevators, and heating and ventilation systems. With energy bills rising by double-digits year after year, it is also important that we look at solutions to control increasing energy costs. This year, we are asking our community to vote on replacing a bond which is being retired with a new \$20 million capital improvement plan to help us achieve these goals. **This new bond will replace an existing bond; therefore will be NO additional costs to taxpayers by approving this proposal.** 

**DEFINING THE PROJECT SCOPE:** The scope of the project is broken down into three basic categories: facilities preservation/maintenance and safety; strategic plan-STEM curriculum support; and energy efficiency/alternative energy.

- *FACILITIES PRESERVATION/MAINTENANCE AND SAFETY:* Two years ago, with the support of the community, we began many significant repairs to our facilities that required immediate attention. Select sidewalks have been replaced, portions of building exteriors and interiors have been repaired, and certain infrastructure projects were initiated. Although a lot has been accomplished, there is still more to do in order to maintain our facilities and keep our learning environments safe.
- *STRATEGIC PLAN-STEM CURRICULUM SUPPORT:* Our current five-year strategic plan calls for expanding our STEM curriculum in all three schools. It is important that the physical space/design of our classrooms and media centers support a focus on providing engaging experiences and creating collaborative workspaces for both our students and faculty. Engineering classes require dedicated "dirty spaces" or "shops" where students can build and implement engineering projects. In addition to the redesign of various classrooms, supplementary equipment is needed for growing programs such as MakerSpace, Computer Science and Project Lead the Way<sup>TM</sup> to include more grades and new learning units.

#### CAPITAL IMPROVEMENT BOND PROPOSAL (CONTINUED)

• ENERGY EFFICIENCY / ALTERNATIVE ENERGY: Reducing energy costs is an important factor in planning the financial stability of our schools for the years ahead. Over the past two years, we have explored many alternative energy approaches and believe that investments in solar power and microturbines will help us control rising energy costs. They will also provide an example for students to learn about energy conservation and sustainability. The anticipated savings in operating expenses would fund these investments over time, making them financially responsible solutions. **FINANCING STRATEGY:** We have evaluated funding options for these projects and have determined that issuing a replacement bond is the best fiscal choice as there will be NO additional cost to tax payers. The following tables provide breakdowns of the total proposed expenditure by school and by project type. If the community approves the bond on May 16<sup>th</sup>, the District will submit its plans to the state for approval. Once approved, a bond or notes will be issued and work will commence based on building priorities. **Since this bond proposal replaces an existing bond and using a conservative interest rate model, there is NO additional cost to taxpayers.**

#### **VOTER ELIGIBILITY AND ABSENTEE BALLOTS**

In order to vote, you must be a registered voter who is at least 18 years of age, a citizen of the US, and a resident of the Ardsley School District for a period of 30 days or more. If you are not available to vote in person you can complete an absentee ballot application available to registered voters by coming to the District Office between 8:00 a.m. and 4:00 p.m. or by downloading a copy from our website <u>www.ardsleyschools.org</u>. The form is located in the 'District Clerk' section under the 'Board of Education' tab. In order for your vote to be counted, it must <u>be received</u> in the Office of the District Clerk by 5:00 p.m. on May 16<sup>th</sup>. Please account for mailing time or bring it to the office.



## **STABLISH A CAPITAL RESERVE FUND:**

On May 16<sup>th</sup>, the community will vote on the establishment of a capital reserve fund. By approving this referendum, the community is in effect allowing the district to set up a savings account to be used for both planned and unplanned future capital projects. The fund will have a zero balance at its inception. Money would only be added to the capital reserve fund if there were a surplus at the end of any school year. For example, if at the beginning of a school year we anticipate high heating costs but we experience a warmer winter, the money saved on heating could be deposited into our capital reserve fund. If there is no surplus at the end of the school year then no money is added to the fund. In this manner, the fund can be used to offset future brick and mortar construction and renovation of district facilities. It is important to note that any future capital projects funded through this capital reserve fund will also require approval of the district voters.

#### FAQ:

#### Will my taxes go up due to the establishment of a capital reserve fund?

No, taxes would not increase due to the establishment of a capital reserve fund. The fund only accrues a balance if there is a surplus of money at the end of the District's fiscal year.

#### Why establish a capital reserve fund now?

There is much uncertainty as to how school districts will receive future state and federal funding in numerous areas, including building aid. In addition, there is also uncertainty in our future facility needs based on new housing developments such as Rivertowns Square, the Water Wheel Condominiums and other single-family home developments. This will allow the District to put aside funds for areas of potential need.

### **\*** BUDGET PROPOSAL:

At the board meeting on April 18<sup>th</sup>, the Ardsley Board of Education formally adopted the 2017-2018 school year budget and is seeking the community's approval on May 16, 2017. This budget is a result of a process that began in January and has involved the administration, the Board of Education and the community.

The proposed budget for the 2017-2018 school year totals \$67,505,261 representing a 1.75% year-to-year budget increase. The proposed budget maintains all present programs, increases services at CRS, and adds class sections at AMS and AHS and a guidance coordinator at AHS.


The District continues to focus on prudent fiscal management. Initiatives such as Quad Village Transportation continue to expand and annual renegotiation of vendor contracts are diligently performed. A lower employer contribution rate for the retirement system along with a higher staff contribution rate for health insurance have helped us both increase alternate sources of revenue and reduce specific costs.

Ardsley continues to be a top-ranked district with student performance being among the highest in the county. We have a dedicated team of administrators and teachers who continue to deliver the high academic standards our community demands while embracing innovation to meet the changing needs of our students.

#### HIGHLIGHTS OF THE BUDGET PROPOSAL:

- Maintains all present programs, offerings and class sizes;
- Adds additional sections in science, English, and social studies at AMS and AHS; a Literacy Coach at CRS and an ENL teacher to be shared by CRS and AMS;
- Increases STEM opportunities for all students K-12 including the expansion of Project Lead the Way<sup>TM</sup>;
- The proposed budget falls below the 2.52% Tax Levy Cap allowable for Ardsley by the state.

**If the community does not approve the school budget on May 16<sup>th</sup>**, State law provides that the Board of Education can, if it wishes, resubmit the same or a different budget to the community for approval one more time by funding a second vote. If the second budget is also rejected or if the Board of Education decides not to resubmit the budget for a second vote, the school will operate on a contingency budget. A contingency budget would require that Ardsley make reductions totaling over \$1,303,398 from the proposed budget.

#### Ardsley: A Great Place to Learn

- Six AHS students achieved finalist standing in the 2017 National Merit Scholarship Program;
- Seventy-two AHS juniors were inducted into the National Honor Society;
- Twenty-six AHS DECA club members placed 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> or 4<sup>th</sup> in state-level competitions. Four students advanced to the DECA International Career Development Conference;
- The **AMS Math Counts** team placed third in the regionals. One Ardsley student will be one of only four students representing NYS on the national level;
- Six **AP Biology** students attended a Robotic Surgery Workshop at White Plains Hospital;
- AHS Science Olympiad team took first place in the Lower Hudson Valley Regional Competition and two students were awarded gold for their Robot Arm at the NYS High School Regional Science Olympiad competition;
- Six AHS students and one AMS student earned Gold and/or Silver Key Awards in the **Scholastic Writing Competition**;
- Over 30 students' **artwork** was shown at Pace University, the Atria Woodlands, Concordia College, and the Katonah Museum;
- Over 40 students from all three schools have participated in NYSSMA All-State Festivals, Bands, Orchestras and Choruses;

- National Gold Medal in Journalism was awarded to an AHS senior in the 2017 Scholastic Art and Writing Awards ceremony;
- AHS Three-Year Science Research students entered 18 projects into the Westchester-Rockland Junior Science and Humanities Symposium competition. Fifteen were recognized with Best in Category or special awards;
- Two Science Research students were awarded the Acorda Scientific Excellence Award, five qualified for the National Genius Olympiad and two others for ISWEEP;
- AHS Select Chorus sang the national anthem at the Westchester Knicks game and has been chosen to perform at Saint Patrick' Cathedral this spring;
- Student athletes on the **Girls Varsity Track Team** were awarded league championship titles in three events and represented Ardsley in the state championship;
- **Girls Varsity Swim Team** placed 4th overall in the Section 1/Conference 2 competition winning first, second and third place medals;
- Ardsley Cheerleaders placed first in the coed divisions in Cheer Utopia and third in the John Jay competition;
- The Girls Varsity Volleyball Team and Boys Football Team took Ardsley to the semi-final playoffs.
