Discussion Item: Review results of Teacher Survey Ms. Lewis

The first question was should we move to schoolwide uniforms?

75% yes, 12% Maybe, 12% no. Will survey parents at the next parent meeting in January.

If we move to school uniforms, we will phase it in one grade level at a time with rising

6th-graders each year until all grade levels are wearing uniforms.

The other survey questions were opened ended about what teachers would like to see from SGC. This feedback will be reviewed in our SGC committees to determine what falls under the SGC umbrella and what does not. We will then follow up with the teachers to let them know what is outside of our parameters and have them vote on their top three of the remaining items that we can do.

Discussion Item: Holiday Plans – Angel Tree/Thanksgiving BasketsDr. Thomas
Thanksgiving baskets will be distributed on 11/21 from 9 to 12. Parents will be picking up in the gym to provide some level of privacy. We could not afford a turkey for each family this year, so they will receive a hen instead.

The Angel Tree will go up the first week in December right after we return from the Thanksgiving break. If there are any students not selected by staff we will use the donation from Tri-Cities to purchase things for those students so they won't go without. An email was sent to staff for help in identifying any students that may have had a change in their circumstances from the beginning of the year or new students that are not coded in our system yet.

Information Item: Principal's Update

Cameras are now active. We have over 120 cameras inside and outside of the building. The new system has face recognition software. We can snap a picture of a person and the system can find and play back any place that person has been around the school.

All three previous SEC vacancies have now been filled. We have a new SEC vacancy due to a teacher's resignation. The paperwork is in process to fill this vacancy.

Both of our pregnant teachers have had their babies and are currently on leave, but should be back soon.

We are still waiting to receive the report from the security assessment.
