### Academic Update -

The West Plains School District hosted a statewide Project Lead the Way (PLTW) Showcase on campus on October 23rd. Teachers and administrators from around the area and state attended as well as the Department of Elementary & Secondary Education, National PLTW leaders, state leaders, DRS administration/staff, and numerous districts from around the area. It was a great day of sharing, learning, and exploring.
