

West Plains School District Board Update

June 23, 2020

Preliminary 2020-2021 Budget, 2nd Read and Approval -

The board approved the budget for the upcoming school year. Board members were presented a preliminary budget to review in May.

Collective Bargaining Agreement -

The collective bargaining negotiations between the Missouri NEA/West Plains Full Time Route Drivers Bargaining Unit and the West Plains School District closed. As a result, an agreement has been approved by the board.

<u>Designation of Amy Ross as ESL, Homeless, and Migrant Student Contact</u>

Each year, school districts are required to designate a school official to serve as the ESL, Homeless, and Migrant student liaison. The Board approved Amy Ross, Special Services Director, to serve in this role.

<u>Set Meal Prices for the 2020-2021 School Year</u>

Based on the Hunger-Free Kids Act the district will increase meal prices by .10¢. Dr. Davis recommended to the board the following breakfast and lunch rates for the 2020-2021 school year.

Student Breakfast

Full Price = \$1.90

Reduced Price = .30¢

Adult Breakfast - \$2.00

Student Lunch

Full Price = \$2.95

Reduced Price = .40¢

Adult Lunch - \$3.10

Approval of Declaration of Equipment at GOCAT as Surplus Property

The board voted to surplus a few items at the GOCAT facility.

Approval of 2020-2021 Salary Schedules

The salary committee proposed movement on all salary schedules and to continue board paid insurance for the 2020-2021 school year. The board approved the movements.

<u>Annual Audit Set for Week of August 17-21</u>

All public school districts are required to conduct an annual, independent audit following the close of the fiscal year. The district audit will be conducted by the accounting firm Shultz, Wood, and Rapp August 17 -21, 2020.

Currently 461 students are enrolled in virtual summer school, kindergarten through 12th grade. Virtual summer school ends on June 26.
