



## West Plains School District Board Update December 21, 2021

### **Academic Update**

Dr. Greg Carter and Tiffany Young gave the board an update on the Annual Performance Report. The update included a recap of the MAP and EOC scores. The scores are open to the public at [www.dese.mo.gov](http://www.dese.mo.gov).

### **Capital Improvements Update**

Dr. Davis gave an update on the district's current improvements, including painting the exterior of the weight room, carpentry class remodel project. He also updated the three-year insurance inspection completed on December 1, 2021.

### **Approval of Updated SRCSP**

The purpose of the Safe Return to In-Person Instruction and Continuity of Service Plan (SRCSP) is to define how the West Plains School District will ensure continued safe operations to maintain the health and safety of students and staff.
