START WITH WHY... WHY SHOULD YOU APPLY FOR FINANCIAL AID?



- Because of the cost of college, many families who don't think they qualify for aid, actually do qualify!
- 2. In 2021, only 49% of public HS seniors in Washington submitted a FAFSA that was successfully processed. 4% of seniors submitted a FAFSA with too many errors to process. 47% didn't apply at all! You won't know if you qualify if you don't apply...
- 3. In 2021, Washington students who didn't complete the FAFSA left \$60 million of PELL grant money on the table. (Grants are 'gift' money that does not need to be paid back.)
- 4. Some **scholarships** require students to submit a FAFSA.
- 5. Financial Aid is available for both 4-year and 2-year programs, including Apprenticeships!

TYPES OF FINANCIAL AID

Merit Based Financial Aid – does not need to be paid back *

- Institutional awards based on high school performance
- The award is usually determined from the admissions application a separate application is not typically required
- Maintaining merit aid requires ongoing academic success in college
- Award criteria can include
- Grades
- Community Service
- Leadership experience
- Talent
- Extra-curricular activities in and out of school.

^{*}There may be repayment required if you drop-out during a semester in which you were using the aid to pay for classes.

TYPES OF AID CON'T.

Need-Based Financial Aid: does not need to be paid back*

- Federal Pell Grant up to \$6,345 per year
- > Washington College Grant— amount varies based on need.



Use Financial Aid grant calculator https://portal.wsac.wa.gov/a/aid-calculator/ to estimate possible Pell and WA College Grant award based on need.

- >Other Grants and Scholarships awarded on a case-by-case basis
- ➤ College-Bound Scholarship signed up for in middle school. Must complete a FAFSA or WASFA to receive the award as a graduating senior
- ➤ Work Study on-campus job funded by Federal and/or State Work Study dollars. Work study dollars must be earned and are paid directly to the student.

^{*}There may be repayment required if you drop-out during a semester in which you were using the aid to pay for classes.

WASHINGTON COLLEGE GRANT



Who is eligible?

WCG is available to <u>eligible Washington residents</u>, including undocumented students. There are no age limits. Recipients must meet program requirements and attend an <u>approved college</u> or program, part-time or full-time.

- Amounts vary based on income, family size, and school or program cost. An eligible student from a family of four with income of \$64,500 or less per year would get a full award.
- For middle-income families, grant amounts are lower. But even someone from a family of four making up to \$107,000 per year can get some money to help pay for college or training.
- Amounts vary based on income, family size, and school or program cost. Students and families can use the <u>financial aid calculator</u> to estimate their potential WCG award.

WASHINGTON COLLEGE GRANT, CONTINUED

What does it cover?

The maximum WCG award amount will cover full tuition at any <u>approved/eligible</u> <u>instate public college or university, including community or technical colleges</u>. At an approved private college or career training program, WCG provides a comparable amount toward tuition and other education-related costs.

Apprentices in a participating program may be eligible to receive the <u>Washington College Grant for Apprenticeship (WCG-A)</u>. WCG-A provides funding for apprenticeship expenses such as **tuition**, **fees**, **and materials**.

How do people apply?

There is no separate application for WCG. Students should complete a state or federal <u>financial aid application</u>, which colleges will use to determine eligibility and make awards. Apprentices enrolled in a program at a community or technical college should also complete a financial aid application

College Grant

LOANS: NEED TO BE PAID BACK

Federal Stafford Subsidized Loan:

- >Subsidized amount does not accrue interest while in college
- >4.99% interest

Federal Stafford Un-subsidized Loan:

- >Unsubsidized amount does accrue interest while in college
- >4.99% interest

Max. annual amount \$5,500 to \$12,500, depending on your year in school and dependency status

- > Repayment begins 6 months after completing OR leaving your program
- Repayment terms can be negotiated
- Repayment terms apply to the student only

LOANS CON'T.

Federal Parent Plus Loan: 7.54% interest

- Loan offered to the parents to help fund their child's education
- > Repayment conditions apply to the parent only
- > Parent Plus Ioans require a parent application and Ioan approval
- If the parent loan is not approved, the student can approach the school or program about increasing parameters of their federal student loans

LOANS CON'T.

Private Loans

- An option for students not eligible to submit a FAFSA, as well as for others
- Requires an application and approval
- ➤ Usually requires a co-signer
- Review terms and conditions carefully as they vary among lending institutions
- Understand repayment requirements before signing!

Free Application for Federal Student Aid – FAFSA

Washington Application for Student Financial Aid – WASFA

ONLY FILE ONE APPLICATION

Pathway for financial aid for most post-secondary programs

- 4-year college or university
- 2-year colleges
- Technical Schools
- Other programs

WASFA can only be used to Washington State schools



WHO CAN FILE A FAFSA?

- √ Have graduated from high school, obtained a GED or completed homeschooling.
- ✓ Must be a US citizen or eligible non-citizen (have a green card, refugee)
- √ The student must have a valid Social Security Number the parent/guardian does not need to have one (when asked for parent/guardian's SSN put all 0's)
- ✓ Register (or already be registered) for Selective Service, if you are male
 ✓ If not registered select "Yes", and the FAFSA site will register you.
- ✓ Must graduate with a 2.0 GPA

Federal Student Aid ID

You will need to make one in order to electronically sign the FAFSA form

Parent/guardian needs to also make an FSA ID

• If parent/guardian does not have a SSN then they do not need to make one. They will simply have to print out the signature page and mail it in.

Free Application for Federal Student Aid/FAFSA - Pathway to financial aid for:

- >4-year college or university
- ➤ 2-year Community College
- > Technical School
- ▶Graduate School
- Many other programs

Required for Federal Student Aid - Pell Grants, federal student loans including unsubsidized loans for non need-based students, and federal work study opportunities.

Often used by states, institutions and private organizations to determine eligibility for non-federal student aid including state or institutional grants, institutional dollars for merit scholarships, and private scholarships that are may or may not be need-based.

You may miss out if you don't file!

WHAT IS NEEDED TO COMPLETE THE FAFSA



<u>Dependent Students</u> will need most of the following information for your parent(s) and a separate FSA ID for their signature.

- > How do you know if you are considered a 'dependent student'?

Bank statements and records of investments (if applicable)

Records of untaxed income (if applicable)

□ A Federal Student Aid ID (FSA ID) to sign electronically
□ Your Social Security Number (not required for the parents to have a Federal Social Security Numbers but the student must)
□ Your Alien Registration Number (if you are an eligible non-citizen)
□ If you have filed income tax, import the most recent financial information directly from your federal tax return (2021) into your FAFSA by using the IRS Data Retrieval Tool. Otherwise, you will need W-2s and other records of money earned



WHO CAN FILE A WASFA?

- > Have graduated from a Washington state high school or obtained a GED
- ➤ Have lived in Washington for 12 months prior to, and **continuously** since earning your high school diploma
- File an affidavit (written promise) to file an application to become a permanent resident of the United States when eligible to apply
- Meet financial eligibility requirements
- A Social Security number is **NOT** required to complete the WASFA

WASFA, Washington Application for State Financial Aid (WASFA)

Pathway to financial aid for:

HTTPS://WSAC.WA.GOV/WASFA

- 4-year college or university
- 2-year Community College
- Technical School and Many other programs

To apply for **Washington College Grant funds**, low income, non-citizen students unable to file a FAFSA due to immigration status may instead complete the free **WASFA**.

- Funds can be used only for institutions in Washington State
- ➤ May be used by institutions to determine eligibility for institutional grants, institutional dollars for merit scholarships, and private scholarships that are may or may not be need-based.

Non-citizen students applying to Out of State colleges, who are unable to file a FAFSA due to immigration status - **check with each school** and ask how/if you can apply for financial aid.

You may miss out if you don't file!

DOCUMENTS NEEDED TO COMPLETE THE WASFA

- ☐ Your DACA or ITIN number (if you have one)
- 2021 income taxes, W-2s and other records of money earned



PAY ATTENTION TO FINANCIAL AID DEADLINES

- **➤ University of Washington-** Priority Deadline is **January 15**, 2023
- Washington State University, Western Washington University,

Priority Deadline is January 31, 2023

- Seattle University, Central Washington University,
 Priority Deadline is February 1, 2023
- ➤ University of California schools- Deadline is March 2, 2023
- ➤ Bellevue College- Deadline for Fall quarter 2023 is June 1, 2023

CSS PROFILE — COLLEGE SCHOLARSHIP SERVICE PROFILE

- Approximately **240** Institutions & Scholarship programs use the CSS Profile to help determine institutional aid eligibility (aid directly from the school, not federal or state aid).
 - ≥2 schools in Washington— Whitman College and Whitworth University
- By filling out the CSS online, you are applying for the **nonfederal** financial aid (institutional aid) at the 240 participating institutions
- Can have a different filing deadline than FAFSA check the school's website
- Complete in <u>addition</u> to the FAFSA, if eligible to complete the FAFSA. **Check directly with the** college if you are not eligible to complete the FAFSA!
- Free for students whose families make \$100,000 or less. Otherwise, its \$25 for the first application, \$16 per additional report
- >Up to 8 CSS Profile fee waivers are available based on SAT fee waiver eligibility

COLLEGE BOUND SCHOLARSHIP

- Need based scholarship
- >You would have signed up in middle school or 9th grade
- > You must submit a FAFSA or a WASFA to access it
- Ensures full tuition payment (4-year, 2-year, and many other programs) for students who:
- ✓ are financially eligible,
- ✓ submit the WASFA or FAFSA, and
- ✓ enroll in a post-secondary program within one year of high school graduation.

SCHOLARSHIPS

➤ How long does it take to earn \$1,000 working a part-time job at minimum wage (\$14.49/hour)?

(More than 65 hours!)

(Less than 65 hours...)
