# WAYS TO EARN COLLEGE CREDIT WHILE IN HIGH SCHOOL

## AP

- Individual classes
- Courses available to students in all grades
- AP scores determined by a single exam at the end of the course
- All courses are 1 year

## IB

- Individual classes or full program
- Courses available to grades 11-12
- IB scores determined by a combination of written and oral assessments completed during the course and an exam at the end of the course
- Courses can be 1 or 2 years

# WHAT IS DUAL ENROLLMENT?

Dual Enrollment is for students at eligible high schools that wish to take college level coursework for credit towards both high school and college graduation requirements.

## **Eligible students include:**

- Students attending public or private high schools in Georgia.
- No residency or citizenship requirement.
- Meet admissions requirements at postsecondary institution.
- Meet high school requirements specific to Fulton County.
- Students must be on track for graduation and in good standing academically.
- Students must be able to adhere to all policies specifically stated in the FCS contract.
- Must not have already received a high school diploma.

# DUAL ENROLLMENT GUIDANCE

## DE Eligibility (10<sup>th</sup>-12<sup>th</sup> Grade ONLY)

- Eligible students may take any approved Dual Enrollment courses listed on the Course Directory, at an eligible participating postsecondary institutions
- Entering or enrolled in 10th grade: may enroll in a **CTAE** course at a technical college **ONLY OR** with SAT(1200) or ACT(26) score that meets the requirements of the Zell Miller Scholarship(may enroll in any approved courses listed on the Course Directory at a TCSG, USG, or private eligible participating postsecondary institution)

## Eligible courses

- Core courses in English, math, science, social studies, or a foreign language upon which the Georgia Student Finance Commission calculates the HOPE grade point average -- 2,613 courses fit this criteria
- Eligible CTAE courses are those aligned with the Department of Education's Career Clusters and Pathways programs and included on the eligible course list - - there are 4,592 of those

# Dual Enrollment Policies



Dual enrollment funding is limited to 30-credit hours or 45 quarter hours. This is the equivalent of 10 courses.



After funding is exhausted all additional classes will be self-pay courses and may be listed as such on your transcript.



The college does not pay for students to retake classes previously failed in the dual enrollment program except under extenuating circumstances as determined by the Student Finance Commission. Retake classes will be billed to the school as self-pay.



After a student withdraws from two dual enrollment courses, they are no longer eligible to participate in dual enrollment.

# PART-TIME VS. FULL-TIME DUAL ENROLLMENT

## Part-Time

- Fewer than 12 credit hours per semester (= full high school schedule-8 classes here)
- Blend of DE classes on the college campus and HS classes at Riverwood
- Schedule must have a total of **4 HS/College credits** in any combination. Number of courses cannot exceed the 4-credit cap. Seniors with a course reduction are capped at combination of 3 HS/College credits.
- Students can replace classes at the high level with college classes to meet both high school and college graduation requirements

## Full-Time

- At least 4 classes totaling 12 credit hours per semester at the college level (= to 8 classes at the high school level). Will only have four college classes listed on the high school schedule
- All classes are taken at the college level
- No courses are taken at Riverwood
- Student is still enrolled at Riverwood and is fully eligible to participate in sports, extracurricular activities, clubs, and events

Most classes for Dual Enrollment Courses are 1.0 credit each

# FCS DUAL ENROLLMENT PROCESS



## Students and Parents:

- Attend Dual Enrollment Night and/or review the Dual Enrollment PPT on the RICS Counseling Site
- Research and apply to the college of your choice by the FCS deadline (**March 31st**). You can apply to more than one school which would be recommended just in case you do not get accepted to one.
- Register to take SAT or ACT and submit your test scores to dual enrollment school or take Accuplacer as required by dual enrollment college.
- **Submit proof of your application, GA Futures account, and intent to participate by going to this link by (March 31st): <https://tinyurl.com/RICSDE2024>.** After submitting your proofs, you will receive a checklist for next steps. **Only students who have submitted all required documents will be invited to schedule classes.**

# FCS DUAL ENROLLMENT PROCESS



## Students and Parents:

- Students that do not meet these deadlines will be scheduled for local high school courses.
- Students **MUST** follow the college class schedule for attendance, testing, etc.
- Students **MUST** continue to meet high school and college grade average requirements to remain in the dual enrollment program.
- Student failure of college courses could affect high school graduation status
- **Dual enrollment is a year long commitment!**





# THE ROLE OF THE SCHOOL COUNSELOR IN THE DUAL ENROLLMENT PROCESS

## Things Your School Counselor **Cannot** Manage

- College schedule and course availability
- College acceptance process and deadlines
- Clear any holds for admissions or registration- you will have to work with the college to clear holds.
- Communicating between you and the college about individualized situations (example: an absence, textbooks, parking pass, a missed quiz, etc.)
- Give parents access to student college accounts and records.
- When grades/semester transcripts are provided to the high school for high school transcript



## Things Your School Counselor **Can** Manage

- Communicate dual enrollment opportunities to students and parents
- Provide academic advisement to the student, post requested courses on GA Futures Funding portal, and answer parent questions as needed throughout the process.
- Ensure students high school schedule is finalized by the start of the school year as long the student provides information in timely manner
- Your counselor is here to advise and support your dual enrollment participation process, but it is important to remember that you will be an **independent college student** while you are still in high school and must meet the same expectations of college student.





# Dual Enrollment Nuggets

- We will have three scheduling advisement meetings for students that have completed the dual enrollment intent to participate steps.
- Check Microsoft Office Calendar and your school email for your scheduled meeting.
- **Failing a Dual Enrollment class** will impact not only your **high school GPA**, but your **college GPA** as well. It can also impact your **HOPE eligibility**, your ability to graduate high school **on time**, and your eligibility to continue in the dual enrollment program .

# Tips for Success in Dual Enrollment Process and Program

- Check your personal and college email accounts DAILY.
- Communicate with your counselor, professors, teachers.
- Attempt to problem solve before asking for help but ask for help if you cannot figure it out.
- Attend required orientation, help sessions, etc.
- **Advocate for yourself.**
- **Stay on top of your assignments.**
- Do NOT drop or withdraw from any classes without written consent from your counselor.
- Take the initiative in making the phone calls and sending emails. **You will be treated like an adult** and your parents will not be able to speak on your behalf at the college level without your consent.
- If you have an IEP or 504, please plan to receive your accommodations at the college level. You will need to coordinate with the college's Office of Disability Services.
