<u>The waiver of the Personal Fitness course is optional</u>. Students electing to waive the course will have the exemption noted on their transcript, however no grade or course credit will be awarded. **Students must fulfill waiver criteria by the last day of fall semester of his/her senior year.** Failure to meet the waiver deadline will result in the student being enrolled in the course for spring semester of 12<sup>th</sup> grade.

## IMPORTANT! 2 separate waivers are required to meet BOE graduation requirement.

- 1. Waiver is due <u>immediately</u> following the completion of their season.
- 2. Once the student has submitted both waivers with required signatures for verification, the waiver will be added to the student transcript.
- 3. Students who sustain injuries that prevent successful completion of the season will not be eligible for the waiver during that season.
- 4. Students who choose to quit, are removed from their team, or are academically ineligible mid-season will not be eligible for a waiver during that season.
