#### **Charter Funds: Expenditure Form**

On July 31, 2020 all Fulton schools received \$30,000 to be spent by School Governance Councils on innovative measures towards achieving strategic outcomes. These Charter Dollars must be spent in accordance with FCS expenditure guidelines and are subject to the same restrictions as other funds in your cost center. In addition, any purchase(s) made using Charter Dollars must be publicly voted on by your School Governance Council and recorded in the <a href="Charter Dollar Expenditure Form">Charter Dollar Expenditure Form</a> (Note: A copy of your expenditure form will not need to be posted on your SGC web page because it will appear on the <a href="FCS Charter System Website">FCS Charter System Website</a>). However, SGCs should make note of any expenditure on their agenda and record voting outcomes related to these funds in their minutes.
