In addition, Mrs. Geathers declined the purchasing of the adjustable teacher desks.</li> <li>o At the time of this SGC meeting, the amount of available funds was not clear, Dr. Mills will follow up to get the exact amount needed to be spent. We will revisit the items wanting to purchase.
