Minutes of the Meeting of the Wyoming City School District Board of Education Tuesday, February 13, 2024 Central Office Conference Room

I. Call to Order

Mrs. Zoller called the meeting to order at 7:31 a.m.

II. 013-24 Roll Call

The roll was called and the following members were present:

Mrs. Broderick, Mr. Feldmeier, Mr. Thomas, Mrs. Yee and Mrs. Zoller

Administration in attendance Tim Weber, Ronda Johnson, Suzy Henke, Ashley Whitely, Tracy Wurtzler, Gina Kirchner, and John Hill.

III. Pledge of Allegiance

Mrs. Zoller led the Pledge of Allegiance

IV. 014-24 Adoption of Agenda

Mr. Thomas made a motion to adopt the agenda. Mrs. Yee seconded the motion.

Yea – Feldmeier, Thomas, Yee, Zoller, Broderick Nay – None Motion carried.

V. <u>Expulsion Appeal Hearing of a regulated individual</u>

Mrs. Zoller began the hearing and confirmed with Mr. and Mrs. Friesen that they wished to hold this hearing in public session. Mr. and Mrs. Friesen indicated that they did wish to hold the hearing in public session.

Mrs. Zoller swore in all who would offer testimony, including Mr. Weber, Dr. Whitely, Dr. Kirchner, Dr. Hill, Mr. Friesen, Mrs. Friesen, and Mr. Wickstrom. The parents are appealing a January 30, 2024 decision of the Superintendent to expel EF (the student) for 71 days pursuant to Ohio Revised Code 3313.66 with 33 of the 71 days held in abeyance. The student is permitted to return to school on Monday, April 8, 2024 if all required steps are completed to the satisfaction of the Administration.

Mrs. Zoller reviewed the rules and procedures of the hearing and verified that all procedural safeguards and proper notices were provided. Mr. and Mrs. Friesen replied in the affirmative.

The Administration presented a binder of evidence and Dr. Hill began offering testimony. Dr. Hill testified that a pocket knife was found at approximately 1:30 on January 17, 2024 and upon asking the student, the student advised that the knife was his. Dr. Kirchner testified to the events of January 18th including a threat assessment, investigation interviews of the student, teachers and parents, and a mental health assessment of the student which all led to Dr. Kirchner's suspension of the student with a recommendation to the Superintendent for expulsion. Mr. Weber and Dr. Whitely testified to the expulsion hearing where all evidence was presented. After considering the evidence, Mr. Weber rendered the decision for a 71-day expulsion. Mr. Feldmeier, Mrs. Zoller and Mr. Thomas asked clarifying questions regarding therapy, whether an IEP existed, and why the student indicated he was bringing the

knife to school. Mr. and Mrs. Friesen asked clarifying questions regarding whether the student was reported to be defiant or aggressive by his teachers and Mr. Wickstrom asked questions about testing administered by the counselors. Mrs. Zoller asked a clarifying question about the threat assessment team.

Mr. and Mrs. Friesen presented three documents for evidence. Mr. Friesen shared information on previous counseling sessions and also discussed the student's report cards from grades 1-4. Mr. and Mrs. Friesen shared beliefs on the laws surrounding IEPs, 504s, and the required length of the blade of a knife. They highlighted interventions and suggested basis of knowledge. Mr. Thomas asked a clarifying question as to why the parents had not requested an evaluation for and IEP or 504 until now. Mrs. Zoller asked a clarifying question regarding interventions being part of the MTSS process. Mr. Wickstrom shared his beliefs that Mr. and Mrs. Friesen are good parents and since the student is a still a growing child, the punishment was too severe.

Mrs. Zoller noted that the Board will deliberate in Executive Session and excused all parties.

VI. 015-24 Executive Session

Mr. Feldmeier moved to have the Board of Education enter into Executive Session to consider the discipline of a regulated individual. Mrs. Yee seconded the motion.

Yea – Thomas, Yee, Zoller, Broderick, Feldmeier Nay – None Motion carried.

The Board of Education entered Executive Session at 9:01 a.m.

The Board of Education returned from Executive Session at 9:40 a.m.

The Board of Education reconvened its regular meeting at 9:41 a.m.

VII. 016-24 Board of Education Decision

Mr. Feldmeier moved that the Board of Education find that the student, EF, violated the student code of conduct by brining a dangerous object on school property. Mr. Feldmeier further moved that the Board of Education affirm the decision of the Superintendent to expel the student for 71 days (February 2 – May 23) with 33 days of the 71 days held in abeyance. Mr. Feldmeier further moved that the Treasurer provide the student and parents with written notice of the Board's action. Mrs. Broderick seconded the motions.
