- Moody's Credit Rating:
 - Moody's upgraded Cherokee County School District credit rating from AA2 to AA1 on February 1, 2024.
 - The Moody's AA1 rating is shared by only three other school districts in the state of Georgia. Additionally, only three school districts in the state have a higher rating, putting CCSD in the top 6% in the state.
 - Increased revenue, excellent budget management and favorable governing authority were contributing factors.
- 2024 General Obligation (GO) Bond Issuance:
 - The School District's current credit rating will have a positive impact on bond sales.
