Actions Taken

Superintendent to Remain in Bibb Through June 2022

On Thursday, April 18, the Bibb County Board of Education voted to modify its contract with Superintendent Dr. Curtis L. Jones Jr., keeping him in his role as Superintendent of the Bibb County School District through the end of June 2022. The Board originally voted to name Dr. Jones Superintendent of the Bibb County School District on February 26, 2015. His first day in Bibb County was April 6, 2015.

“The Board is very pleased with the job Dr. Jones has done to bring continued stability to the Bibb County School District. As evidenced by his recognition as 2019 National Superintendent of the Year, he has been able to move our district forward, and we want him to continue to provide that leadership for our district and our community. We are pleased with Dr. Jones’s leadership, and the Board feels we have a good working relationship and are providing him the support he needs to improve the District,” said Board of Education President Lester Miller.

New Assistant Principals Appointed; Resolution for Land Bank Authority Approved

On Thursday, April 18, Board members approved the appointments of two assistant principals. Valeka Franklin was appointed Assistant Principal of Rutland High School, and Dr. Sarah Mayberry was appointed Assistant Principal of Taylor Elementary School.

14 New School Buses Approved; 10 Older Buses Approved for Surplus and Sale

On Thursday, April 18, Board members authorized the District to issue a purchase order for 14 school buses from Yancey Bus Sales and Service. Currently, the District’s fleet consists of 200 school buses. This purchase will include 10 72-passenger buses and four 54-passenger buses with wheelchair lifts. These new buses will be equipped with air conditioning. They will replace 14 older buses that have been in service for a minimum of 21 years, have traveled a minimum of 253,000 miles and that are not equipped with air conditioning.

The purchase will be paid for with Education Special Purpose Local Option Sales Tax (ESPLOST) funds. For more information on the school bus purchase action item, [click here](#).

Additionally, Board members approved the surplus and sale of 13 vehicles and authorized the Board President and Superintendent to sign a resolution for this purpose. The Transportation Department identified these vehicles, which are at least 17 years old and have traveled in excess of 127,000 miles. These vehicles were identified for disposal after the Board approved the purchase of 10 new school buses in August 2018. On Thursday, April 18, Board members approved a resolution with the Macon-Bibb County Industrial Authority for the Macon Bright Program and authorized the Board President and Superintendent to sign the resolution. In February, representatives of the Macon-Bibb County Industrial Authority presented the District with information about the new initiative designed to address industrial and commercial blight in Bibb County. Board Receives Update on Georgia Milestones Administration

On Thursday, April 18, Board members received an overview of the District's administration of the Georgia Milestones assessments for spring 2019. Board Provided with E-rate Historical Review

On Thursday, April 18, Board members received an overview of District's E-rate historical information. The federal E-rate program began in 1998 to provide discounts to assist eligible schools and libraries to obtain affordable internet access. E-rate funds the following service types:

- Data transmission services and/or internet access;
- Internal connections;
- Managed internal broadband services; and
- Basic maintenance of internal connections.

Discounts range from 20-90 percent of the costs of eligible services, depending on the level of poverty and the urban/rural status at the school district level. Eligible schools, school districts and libraries may apply individually or as part of a consortium. The District is eligible to receive funding from E-rate up to 90 percent of the cost to purchase products and services necessary to give students and teachers faster and more widely available internet access.

A major "attestation audit" on the 2016 E-rate funding for the District will be completed in May 2019. E-rate auditors have spent more than 21 months examining pertinent records. Auditors inspected several schools in the District to look at technology installed in order to ensure compliance with all federal regulations. The District received no findings or concerns of any kind.
