PRINCIPAL UPDATE: Ms. Freeman reminded everyone that we are still working towards specific goals for this school year. Tier 1 as measured by I-ready Reading by May and the same in Math. Ms. Freeman shared that CES had on documented case of COVID-19. The individual was last on campus on Friday, October 16th. Ms. Freeman shared the closing matrix and we are currently at Level 1. Ms. Freeman asked for questions regarding the closing matrix. One question regarding contact tracing: Board of Health and District Personnel completes the contract tracing.

CES had to Re-Shuffle their teaching models. We currently have 50% present; 51% virtual. We currently teaching Separated model and the Simultaneous model in an effort to address student needs. The first district site visit will be Oct. 26th.
