#### **Informational Items**

- Prior to the approval of the agenda, one item about electing officers was deleted and one item about the Cross Council Meeting was added. After the deletion and addition of those two items, Aimee motioned to approve the agenda and Jennifer seconded, and the Agenda was approved unanimously.
- Principal's Update
  - Lisa started off by giving an update on hiring a Kindergarten teacher. The position has been posted and are currently looking to fill the position, but currently classes are not at their limits.
  - Lisa gave a safety update regarding last Friday October 13<sup>th</sup>, with the current outside climate. The building had heightened awareness and monitoring. Lisa called parents who were concerned to reassure them of the supports in place to provide students with safety.

- Officer training
  - All officer training has been completed. The SGC is waiting to hear back from the county regarding the background checks.
- EA Update: Brooke Brown gave updated from Eagle Alliance as follows:
  - Investment Committee met to discuss new additions to the school. The additions are sunshades for the play pad, marquee sign, and adding acoustics to the cafeteria to reduce noise level.
  - Bus driver appreciation week is ongoing.
  - Mother Son date night is this Friday at Jump Start. Daddy daughter date night is coming up and will be held at Riverwood High School. It is a Taylor Swift themed dance.
