- S. Stephens attended the cross council meeting and was able to gather some ideas. One of the ideas was shared from Webb Bridge – they are completing a service learning project where the SGC purchased book and integrated it with a service learning project. They are pariing up with a foundation to complete the project.
- SGC discussed that the semester action plan is similar to previous years and Hopewell is hoping to see some better results this year.
  - Hopewell purchased teachers and coaches to see improvement this year.
  - There will be a mid-year survey to see if students feel connected to the school.
  - School is building a team to address some of the offensive language/messages that has been happening at school.
- SGC discussed reaching out to staff about possible requests. M. LeMoyne plans to reach out to staff during second semester since most teacher requests were taken care of 1<sup>st</sup> semester with PTA mini-grants or school funds.

### 7:52am Action Item: Approve Flex Fund Purchases

Principal

- SmartPass is a digital monitoring system that other schools are already using to see when students are in and out of the classroom. You can set a building limit to limit the number of kids who are in the hallway at one time. It can limit passes to certain locations. It can also limit specific kids being in the hallway at the same time. This system also collects data. The plan is to begin using it second semester and the cost is \$1728 for one semester.
  - SGC agrees that this is a great tool. Parents have heard from their children about the bullying and inappropriate behavior that happens in the hallways and bathrooms.
  - o This product is approved by Fulton County Schools.
  - The SmartPass privacy policy says that they will not share or sell data that is tracked.
