7. Student Achievement Liaison:

Mrs. Burnem handed out February Student of the Month Awards.

8. Superintendent's Report / Principals' Report / Supervisors' Report:

Mr. Mike Chancey, Meigs High School Principal, distributed a monthly report. Current enrollment is 505 with an attendance rate of 85.92%. There are 106 seniors with 7 in jeopardy of not graduating. Mr. Chancey talked about upcoming testing and important dates in March. Lastly, he spoke about prom plans, how much money has been raised so far, and the anticipated expenses.

Ms. Vickie Jones, Meigs Middle School Principal, distributed a monthly report. Current enrollment is 340 with an attendance rate of 91.07%. 37 students have been absent for 18+ days. Ms. Jones distributed data from the recent STAR screening. Lastly, she talked about student activities, upcoming events, and state testing.

Mrs. Jody Howard, Meigs Intermediate Principal, distributed a monthly report. Current enrollment is 346 with an attendance rate of 92.68%. She advised that 22% are chronically absent. Mrs. Howard talked about the new dyslexia law and what the future may hold. Lastly, she talked about the upcoming events and testing schedule.

Mrs. Kristin Baer, Meigs Primary School Principal, distributed a monthly report. Current enrollment is 349 with an attendance rate of 91.26%. Mrs. Baer advised that 36% of students are chronically absent. Meigs Primary is working on attendance motivators to help. She went over upcoming events for March and April. Mrs. Baer finished by noting that Sammy Barr, Meigs Primary Teacher has published a book and Meigs Primary will have a signing day on March 14, 2024.
