Dear Parents and Community Residents:

Under the provisions of New York State's Sex Offender Registration Act, also known as "Megan's Law", the Clarence School District has recently received notification from the Erie County Sheriff about a Level 2 sex offender now residing within our District.

An assigned risk level of 2 means that the risk to the community is moderate. Megan's Law clearly defines the information that can be disseminated by the police about convicted offenders living in their jurisdiction and the school district in turn is committed to passing along that same information to our residents. For Level 2 offenders, general information including zip code, photo and background crime information can be released. (*Please note: under the provisions of the law, police agencies cannot release the exact home address for Level 2 offenders.*)

You can be assured that the school district is taking all necessary precautions to keep our children safe. In addition to notifying school employees and the general public we are also briefing staff members responsible for after school activities. I encourage you to talk with your children about being safe and how to make smart decisions for their protection. Questions or concerns related to this matter should be directed to the Erie County Sheriff at 858-2903. Please be aware that this will be the last paper notification of level 2 or level 3 sex offenders that is mailed by the school district. We will transition to an electronic format for sex offender notifications at the beginning of the 2017-18 school year. 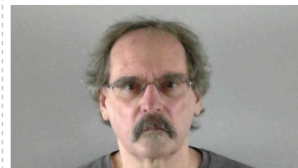
