- The score of current assets to current liabilities ratio for the school district sufficient to cover short-term debt will increase from 4 points in November 2020 on the Financial Integrity Rating System of Texas (FIRST) rating to 8 points by November 2024.
- The number of consecutive years a balanced budget is presented to the board for adoption/approval will increase from 1 in August 2019 to 5 in August 2024.

Superintendent shall not allow a negative culture, such as bullying, to exist at Fabens ISD.

- The number of events for parental engagement will increase from in June 2020 to ____ in June 2024.
- The number of campuses and departments conducting yearly comprehensive culture/climate surveys will increase from 50% in May 2020 to 100% in May 2021.
- The number of campus having a PBIS team will increase from 2 in August 2020 to 4 by August 2021.
