

CURRENT ISSUES


The Site Permit delayed the start of earthwork by 5 weeks. This will result in earthmoving activities, stormwater, electrical underground, concession building foundation, and masonry shifting deeper into the winter months.

- Unsuitable Soils were identified at the west side of the track on 12/8/23. Robertson Construction is working with NLSD's geotechnical consultant (PSI) to develop the most cost effective method for remediating these soils.







QUALITY CONTROL

Northridge Athletic Facilities & MS Plumbing Repairs

The monitoring of safety and quality of work is an important issue which Robertson Construction Services and the Subcontractors take very seriously. Robertson continually monitors the Subcontractor's safety practices and quality of work via on-site inspections.

Quality Control

We are reviewing all of the work in place to verify it was installed as designed. Any discrepancies from the Contract Documents are listed in Field Reports and distributed to the proper Subcontractor for corrections. We also discuss the items in our weekly subcontractor meetings to ensure each concern has proper closure. The entire Design Team will take a thorough and proactive approach to items. Robertson will monitor reports from the design team, PSI, MCS, and the School District. Corrections will be made in response to these reports.

Pre-installation meetings are being scheduled with the Architect and appropriate subcontractors to ensure the work is consistent with the contract specifications and will be installed properly.
