RESOLUTION TO ORDER SCHOOL BOARD ELECTION

WHEREAS the Texas Education Code, Section 11.051, and the Texas Election Code, Section 3.001, require the governing board of any political subdivision, to include a public school district, to order an election for officers of that political subdivision, and

WHEREAS the terms of office of Jason Adams and Monty Renfro, members of the Board of Trustees of Anna Independent School District will expire on May 4, 2024, or when their successors are duly elected and qualified, and

WHEREAS on the 4th day of May 2024, a Board of Trustees Election will be held in Anna Independent School District, and

WHEREAS it is necessary for the Board of Trustees for Anna Independent School District to pass an order establishing the procedure for filing for and conducting said Trustee Election.

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF TRUSTEES OF THE ANNA INDEPENDENT SCHOOL DISTRICT:

1. That an election be held on May 4, 2024, during the hours of 7:00 a.m. to 7:00 p.m. at the Anna City Municipal Complex, 120 W. 7th St, Anna, Texas 75409, to elect two (2) members of the Board of Trustees, Place 2 and Place 6, for a full three-year term. Applications for a place on the ballot must be filed no later than 5:00 p.m., February 16, 2024. The main Early Voting polling place shall be held in the Lobby of Anna City Municipal Complex, 120 W. 7th St Anna, Texas 75409, and at other early voting locations as designated by the Collin County Elections Administration Office, and said places of early voting shall remain open for at least nine hours on each day of early voting which is not a Saturday, a Sunday, or legal state holiday, beginning on the 12th day (Monday, April 22, 2024) and continuing through the 4th day (Tuesday, April 30, 2024) preceding the date of the election.
 - a. Early Voting Dates and Times:
 - Monday, April 22, 2024 – Friday, April 26, 2024, 8 a.m. – 5 p.m.
 - Saturday, April 27, 2024, 7 a.m. – 7 p.m.
 - Monday, April 29, 2024 – Tuesday, April 30, 2024, 7 a.m. – 7 p.m.
2. That all requests by candidates to have their names placed upon the ballot for the above mentioned Trustee election for Places 2 and 6 shall be timely made in accordance with the law and shall be in writing, shall state the number of the position (place) for which such person is filing as a candidate, shall be signed by the candidate and filed with the Secretary of the Board of Trustees, Anna Independent School District Administration Building, 501 South Sherley Avenue, Anna, Texas 75409, not earlier than Wednesday, January 17, 2024, (30th day before filing deadline) and not later than 5:00 p.m. on Friday, February 16, 2024

(78th day before Election Day). The deadline for write-in candidates is 5:00 p.m. on Tuesday, February 20, 2024.


All candidates shall file with said application the loyalty affidavit required by Section 141.031(a)(4)(K) of the Election Code.

3. Applications for ballot by mail shall be mailed to Bruce Sherbet, Collin County Elections Administration Office, 2010 Redbud Blvd., Suite 102, McKinney, Texas 75069. The Early Voting Clerk's phone number is 972-924-1990, e-mail address is election@collincountytx.gov, and Internet website is <https://www.collincountytx.gov/elections/Pages/default.aspx>. The email address at which the Early Voting Clerk may receive applications for a ballot by mail is: election@collincountytx.gov. Applications for ballots by mail must be received no later than the close of business on April 23, 2024.
4. Federal Post Card Applications (FPCAs) must be received no later than the close of business on April 23, 2024.

Approved and ordered on this 15th day of February 2024 by the Board of Trustees of the Anna Independent School District by a vote of 6 AYES and 0 NOES with 0 PRESENT AND NOT VOTING at a meeting which was duly and legally called and opened to the public as provided by law.


