IN GENERAL, WE MEET IN PERSON ONCE AND SOMETIMES TWICE PER WEEK WITH GOOGLE ASSIGNMENTS THROUGH THE REMAINING DAYS. (IN-CLASS MEETING DAYS ARE HIGHLIGHTED ABOVE. I WILL BE GIVING TESTS ON OUR IN-CLASS MEETING DATES...AGAIN, NO ABSENCES EVEN IF THEY ARE SCHOOL RELATED. PLEASE CHECKS SCHEDULES AND PLAN ACCORDINGLY.)

- DRIVING WILL BE SCHEDULED AFTER SCHOOL, SATURDAYS AND STUDENTS WHO WOULD LIKE TO VOLUNTEER TO DRIVE ON SUNDAYS. DEPENDING ON WEATHER AND STUDENT SCHEDULES, THE DRIVING SHOULD BE COMPLETED AT THE SAME DATE THE CLASS ENDS OR SHORTLY THEREAFTER DEPENDING ON THE WEATHER. INSTRUCTORS MAY NOT DRIVE EVERY SUNDAY.
- STUDENTS MUST BE AT LEAST 14 BY OCTOBER 22, 2023 TO ENROLL IN THIS CLASS. THE STUDENT MUST BE AT LEAST 14 ½ THE FIRST NIGHT OF CLASS...**NO EXCEPTIONS.**
- THE TEST FOR THE TELL PERMIT (TRAFFIC ED LEARNER'S LICENSE) WILL BE GIVEN ON WEDNESDAY, MAY 1, 2024 DURING CLASS. I WILL DISTRIBUTE APPLICATIONS FOR A LEARNER'S PERMIT THE FIRST NIGHT OF CLASS. THEY NEED TO BE RETURNED TO ME BEFORE MAY 1, 2024 WITH A COPY OF THE FOLLOWING INFORMATION:
 - CERTIFIED BIRTH CERTIFICATE OR PASSPORT OR MONTANA I.D. CARD. (IF YOU DO NOT HAVE A CERTIFIED BIRTH CERTIFICATE FOR YOUR CHILD, IT IS HELPFUL TO APPLY FOR A NEW COPY IN ADVANCE ESPECIALLY IF THEY WERE BORN IN ANOTHER STATE.) I DO NOT KEEP THE BIRTH CERTIFICATES, PASSPORT OR MT ID CARD—I SIMPLY NEED TO VERIFY BIRTHDATE AND SPELLING OF NAME ON THE APPLICATION AND WILL PROMPTLY RETURN CERTIFICATE/PASSPORT/MT ID TO THE STUDENT.
 - STARTING SEVERAL YEARS AGO, STUDENTS HAVE TO SHOW A SECOND FORM OF ID. THE TYPES OF SECONDARY ID INCLUDE SCHOOL ID OR SOCIAL SECURITY CARD OR FEDERAL TRIBAL ID.
 - I AM NOT ALLOWED TO GIVE THE LEARNER'S PERMIT TEST TO STUDENTS WHO DO NOT RETURN PROPER PAPERWORK. THEY WILL HAVE TO GO TO THE DMV. CURRENTLY THEY ARE BOOKED OUT FOR APPROXIMATELY 3 MONTHS.
- PLEASE DO NOT MISS A SCHEDULED DRIVE. I HAVE TO SEND THE OTHER DRIVING STUDENT HOME IF YOUR SON OR DAUGHTER DOES NOT SHOW. THIS COULD RESULT IN FAILURE OF THE CLASS.
