2024/2025 yearly cost for the NAEYC Accredited 5-day School-day Plymouth FRC Preschool Program will be \$5,500.00 a year or 10 monthly installments of \$550.00 (tuition costs calculate to less than \$5.00 per hour of service) ½ day sessions are prorated, with **\$25. Application fee.**

Tuition assistance is provided by the OEC's School Readiness and United Way of West Central CT grants and are contingent upon awarded funding. We are unable to promise family assistance until the June 2024. This program offers financial assistance using a "Sliding-Fee Scale" and all families applying will be given an **estimation** of tuition for the school year. We will need proof of Income in the form of W2's, front page of 1040, or 4 consecutive pay stubs. Please check the appropriate box on the application for tuition assistance packet to be sent to you.
