UPDATE ON CAMPUS EMERGENCY DRILLS- Chief Velez

- Required drills – We have some complete, some scheduled and some that still need to be done and/or added in the software. We are working on staying in compliance.

UPDATE ON CAMPUS DOOR SAFETY AUDIT- Chief Velez

- 1 at Elementary in February – passed
- 1 at High School in March – passed
- Jr. High – scheduled for next month

THREAT ASSESSMENTS TO DATE- Chief Velez

There have been 7 assessments. 4 at Elementary (threats/mental health called). 1 at Junior High (unfounded) and 2 at High school (unfounded/hoax)

BUS SMART TAG UPDATE- Chief Velez

Equipment, software and cards have arrived. Implementation in process. Full implementation in June/employees will be trained.

RAPTOR ALERT IN CLASSROOMS/SMARTBOARDS- Chief Velez

Raptor alert on smartboards did not work as planned. It is an Android based board and has to be working through a desktop to get the alert.

MISCELLANEOUS

- Emergency Operations Plan review complete. All areas are clear. We received the report 3/21/2024
- Narcan – questions posed whether or not staff can have it available. This needs to be discussed with the Board. If approved, staff needs to be identified and trained. Mr. Fuller will check with TASB for generic policy information.
- TEA – District Vulnerability – Received information on 3/21/2024 that Safety and Security has been added with existing Academics and Finance. These are the 3 areas schools can lose accreditation.
