# **DESCRIPTION OF BASIC FUNCTIONS AND RESPONSIBILITIES:**

Under the direct supervision of the Educational Services Division, the position is responsible for instructing students in an elementary school setting from grades TK through 6th Grade. The Visual and Performing Arts (VAPA) teacher ensures each student experiences success in developing VAPA skills, implements culturally responsive teaching practices, instructs students in alignment with the California Standards for the Teaching Profession, and provides high-quality VAPA implementation. The VAPA teacher works in collaboration with classroom teachers, other Visual and Performing Arts teachers, and parents/guardians of students in their classes, and is responsive to inquiries, concerns, and feedback that they may offer.

#### **TYPICAL DUTIES:**

- Plan and prepare instructional activities that reflect the California Arts Standards
- Deliver regularly scheduled, sequential, standards-based instruction
- Utilize educational materials that reflect the diverse educational, cultural, and linguistic backgrounds of the students served
- Provide instruction that reflects multiple perspectives and multicultural education
- Create a culturally responsive educational climate that reflects diversity and encourages constructive, supportive, and productive student interactions
- Create and maintain a rigorous learning environment with high expectations and appropriate supports for all students
- Establish and communicate clear objectives for all learning activities using classroom routines, procedures, and norms
- Manage student behavior in the classroom by implementing approved positive behavior interventions and support procedures
- Develop positive based incentives to keep students engaged in class
- Create engaging and meaningful short and long-term lesson plans and modify them accordingly throughout the year
- Work collaboratively with the VAPA team
- Create project and/or technology-based assignments designed to enhance learning
- Integrate competencies, goals, and objectives into lesson plans
- Conduct timely communication with school staff, administration, and parents related to scheduling and coordination of classes and special events
- Collaborate with staff and administration in planning and organizing school performances
- Plan and develop exhibits and performances in the Visual and Performing Arts
- Observe and evaluate student performance and provide comprehensible feedback to students

- Update and advise parents and/or legal guardians of student progress for the purpose of communicating expectations; students' achievements; developing methods for improvement and/or reinforcing classroom goals in the home environment
- Perform basic attendance accounting and clerical services as required
- Attend mandatory meetings
- Participate in ongoing, purposeful, and relevant professional development sessions
- Read and stay abreast of current research and topics in education
- Respond to inquiries from a variety of sources (e.g., other teachers, parents, administrators, etc.) to resolve issues, providing information and/or direction
- Monitor appropriate use and care of equipment, materials, and facilities
- Support the initiatives of the District
- Attend to contractual obligations and abide by OGSD and Board of Trustees policies and procedures
- Perform other related duties, as assigned, to ensure the efficient and effective functioning of the work unit
