There have been multiple e3 community engagement opportunities during the 2020-2021 school year to gather and streamline feedback to inform the development of the Expanded Learning Opportunities Grant Plan (ELOG) and the Local Control Accountability Plan (LCAP). The extensive feedback from the ELOG and LCAP was used in the development of this ESSER III expenditure plan.

Community engagement opportunities throughout the 2020-2021 school year targeted the following stakeholder groups: scholars, parents/guardians, school administrators, learning facilitators, support staff, ELAC/DELAC, and the parents/guardians of students with disabilities, students experiencing homelessness, students in foster care, and students learning English as a Second Language. The platforms used to solicit meaningful feedback from the e3 community included: family and staff surveys (Google Forms) sent via email and by Parent Square, virtual community forums (e.g. Think Tanks, SSC, Parent University), and student achievement data analysis meetings/dialogue to identify students in need of academic or social-emotional support. Furthermore, at a regularly scheduled Governing Board meeting to be held on October 12, 2021, e3 Civic High will include on the agenda the approval for the ESSER III plan and the opportunity for public comment. Prior to this meeting, the ESSER III plan will be posted on the e3 Civic High website for parents/guardians and staff to review and provide feedback using a Google form.

A description of how the development of the plan was influenced by community input.

Community input overwhelmingly emphasized the importance of providing a safe in-person learning environment, continued focus on college and career, an expansion of choice and voice for what is learned and how learning takes place in school (e.g. topics of interest to scholars, more time for collaborative learning and relevance of content and projects), and dual enrollment opportunities to both engage students and to ensure college and career readiness. Mental health, Social Emotional Learning, and the continued use of positive behavior supports and culture building (e.g. access to counseling team, focus on cultural competency and team building activities) were of high importance across

all groups and was noted as an ongoing area of emphasis and critical for school engagement and continued positive school culture.

Conversations and survey data did express concerns regarding learning loss due to the pandemic, and further parent conversations reflected support for continued tutoring services during/after school and on Saturdays (Saturday Academies, testing workshops). Individual calls, Virtual Home Visits, check-ins by learning facilitators and other school staff were highlighted as an area which helped students and families continue to feel connected, and it was requested that these activities are a part of our ongoing practice.

- "Culture and Climate of engagement and trying new things and multiple answers; the variety of programs and initiatives available to scholars."
- "There is an extensive support staff that reaches out and connects with the families of scholars and a lot of work put into the individual care of the scholars."
- "The scholars are given help in many different ways (they get summer school, access to support staff, tutoring, competency based learning)."

Specific Stakeholder Input, Parents:

- "My scholar is more college ready and prepared for challenges."
- "Clean, safe, respectful, very encouraging atmosphere."
- "Their positive and supportive response to virtual/remote learning...Leadership, Individual & Team building (scholars academic/social skill)."

Specific Stakeholder Input, Scholars:

- "The things I like about this school is that it promotes social equality and justice for scholars."
- "How focused it is on college. I am planning on going to college after high school... it has helped me figure out what college I would like to go to and how I might get there."

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

- Addressing learning loss among students, including underserved students, by:
 - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
 - Implementing evidence-based activities to meet the comprehensive needs of students,
 - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
 - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
