Requests to participate in public comments via phone will be accepted via email the day of the meeting from 5 to 5:30 p.m. for the first timeframe and from 6 to 6:30 p.m. for the second opportunity. Requests should include the speaker's name, phone number, as well as topic, and must be emailed to the Executive Administrative Assistant to the Board, Robyn Cushingberry, at robyn.cushingberry@beaufort.k12.sc.us. Requestors will subsequently receive a phone call during their respective public forum time and should be ready to speak.

Citizens desiring to participate in-person must fill out a Public Comment Card that can be obtained from the Board Clerk upon arrival.

In the event the Board has not finished addressing all items listed on the April 2, 2024, Agenda, the Board will reconvene at 6:00 pm on April 3, 2024, the next business day to finish the agenda items.
