# ENTERPRISE HIGH SCHOOL 2024 SUMMER SCHOOL



Dates: June 4 – July 18 (Drivers Ed follows a different schedule)

All instruction will be provided online via ACCESS (except Driver's Ed). Students may complete all of their coursework (with the exception of tests) at home OR they may work in the Library @ EHS. Students can work at their own pace. Tests are password protected and MUST BE TAKEN AT ENTERPRISE HIGH SCHOOL proctored by an EHS ACCESS Facilitator Monday - Thursday from 8 am to 12 pm. Credit Recovery students should plan to test more often than traditional courses.

There will be a mandatory Summer School Orientation the morning of June 4th @ 8:00 am in the MPR for NON DRIVERS ED CLASSES. Log in information will be given at this meeting. Drivers Education will have a separate orientation.

Driver's Ed instruction will be provided via Google Classroom. This course requires students to complete approximately two weeks of virtual coursework and fulfill minimum driving requirements. More information will be provided at the Drivers Ed Orientation.

COST: The cost for a traditional summer course is \$200 per credit hour (\$100 for ½ credit).

Students who have previously attempted a course and failed the course with no lower than a 40 average may take a credit recovery course\*. Credit recovery courses cost \$50 per class. \*NCAA does not accept Credit Recovery Courses.

Students may pay with cash or check in the guidance office. Summer school is self-supporting; courses are offered on the basis of enrollment and funds collected.

### SUMMER SCHOOL COURSE OFFERINGS

- Driver's Education (½ credit, \$100)
- Career Preparedness (1 credit \$200)
- Health (½ credit, \$100)
- Government and Economics w/ Career Prep B (1 credit, \$200) rising seniors may take Government (½ credit) and Economics (½ credit). Students must enroll in BOTH Government and Economics AND Career Prep B unless a credit for one has already been earned. These courses are no longer offered as Credit Advancement students must complete the entire course. Upon course completion, students must take and pass a required Civics exam at Enterprise High School that is required for graduation. Information on times and dates of this exam will be provided via student email.
- US History II rising juniors may take US History II (1 credit, \$200).
- Environmental Science rising juniors OR seniors may take Environmental Sci (1 credit, \$200)
- Earth & Space Science rising juniors OR seniors may take Earth & Space Sci (1 credit, \$200)
- Anatomy & Physiology rising juniors OR seniors may take Anatomy (1 credit, \$200)
- Physical Science rising sophomores may take Phys Sci (1 credit, \$200)
- US History I rising sophomores may take US Hist I (1 credit, \$200)

- <u>Credit recovery (\$50)</u> any student who previously failed a class with a final average of no less than 40 may participate in credit recovery at a cost of \$50 per course. Students may register for only one class at a time; however, upon completion of a course, students may register for an additional class, if time permits. The last day to enroll in a course is June 24th. STUDENTS MUST SEE A GUIDANCE COUNSELOR PRIOR TO REGISTRATION TO INSURE PROPER PLACEMENT. \*The NCAA does not accept Credit Recovery Courses.

### **DRIVER'S EDUCATION CLASS INFORMATION**

Registration for Driver's Ed will be on April 18th, 2024. A link will be posted to the EHS Website at 8:30 am the morning of April 18th. You will be notified on the same day if you have successfully secured a spot. You will have until April 26th @ 3:00 to pay the \$100 registration fee. If you are waitlisted, please continue to check your email for spots to open up due to non-payment.

Students MUST have a valid driver's permit by June 17th, 2024 to take the class.

Payment in cash or check will be accepted. We will not be able to accept debit/credit cards.

Space is limited to ensure we meet the minimum driving requirements for each student. Each student will drive with the instructor for approximately six (6) hours (divided into two driving experiences). Exact driving days will be determined once the course has started. Students may choose to complete the driving hours in June or July at the initial meeting.

Following the finalized enrollment of the Summer Driver Education Course, students and a parent/guardian must attend a mandatory informational meeting on May 2nd at 6:00pm in the EHS Competition Gym.
