[RCW 28A.200.010](#) requires that each parent, whose child(ren) are receiving home-based instruction shall:

1. File **annually** by September 15 of the school year or within two weeks of the start of any public school quarter, trimester or semester, a signed Declaration of Intent, that he/she is planning to cause his/her child(ren) to receive home-based instruction, with the superintendent of the public school district within which the parent resides.
2. Home-based instruction shall consist of planned and supervised instructional and related educational activities including a curriculum and instruction in the basic skills of occupational education, science, mathematics, language, social studies, history, health, reading, writing, spelling, and the development of an appreciation of art and music, provided for a number of hours equivalent to the total annual program hours per grade level, established for approved private schools under RCW 28A.195.010 and RCW 28A.195.040.
3. Ensure that a standardized achievement test, approved by the State Board of Education, is administered annually to each child by a qualified individual or that an annual assessment of the student's academic progress is written by a certificated person, who is currently working in the field of education.
4. Failure of a parent to comply with the duties in this section shall be deemed a failure of such parent's child(ren) to attend school without valid justification under the compulsory Attendance Law.
