**SUMMARY & BACKGROUND**

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

**ARP-ESSER Application – Part 1:** The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

**ARP-ESSER Application – Part 2:** The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. **APPLICATION PROCESS FOR LEA ALLOCATIONS OF ARP-ESSER SEA RESERVE FUNDS**

The federal ARP statute requires SEAs to reserve:

not less than 5 percent of the total amount of grant funds awarded to the State (\$449.4 million) to carry out activities to address the impact of lost instructional time by supporting the implementation of evidence-based interventions;

not less than 1 percent (\$89.9 million) to carry out the implementation of evidence-based summer enrichment programs; and

not less than 1 percent (\$89.9 million) to carry out the implementation of evidence-based comprehensive afterschool programs.

The 2021-22 enacted state budget directs that these required SEA set-asides be allocated as grants to specified school districts. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. An SEA must allocate at least 90 percent of its ARP ESSER grant funds to its LEAs (including charter schools that are LEAs) in the State in the same proportion that the LEAs received under part A of title I of the ESEA in Fiscal Year 2020, as required by section 2001(d)(1) of the ARP Act; and section 2001(e) of the ARP Act prescribes certain mandatory and permissive uses of LEAs' funds. The Board of Education held a meeting on June 7, 2021 and presented its draft ARP-ESSER plan. Public comments were sought at this meeting. The draft plan was also posted on the district's web site for review. The posting also provided a link to an online form, seeking public comment and input regarding the funding plan.

The following stakeholders were engaged to assist with developing a plan to use these funds: Superintendent of Schools, School Business Administrator, Assistant Superintendent for Curriculum, Data, and Assessment, High School Principal, Director of Special Education, Response to Intervention Teachers (2), Secondary Teachers (2), Middle School Teachers (2), Elementary Teachers (2), English as a New Language Teacher (1), Middle School Counselor (1), Board of Education Member (1), Community Members/Parents (3).

The District will continue to engage stakeholders throughout implementation of the plan via semi-annual meetings every January and September. The first followup stakeholder engagement meeting is scheduled for January 28, 2022.

ARP-ESSER LEA Base 90% Allocation funds will not be used in order to continuously and safely open and operate schools for in-person learning. Funds are allocated in the district's general fund to safely open and operate schools for in-person learning for the purchase of instructional technology, personal protective equipment, sanitation and for staff wages.

- 4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.**

Data is derived from multiple sources including homework, quizzes/tests and daily checks for understanding. Data from these sources can be both qualitative and quantitative, and is used to measure students' comprehension of the material being presented. The district also utilizes several instructional technology applications used to identify student needs and monitor student progress. Data from these sources is often quantitative. Using research of Fisher, Mendling, and Mather as well as others, our teachers and staff will identify student needs and implement tailored interventions based in part on data gathered from checks for understanding and instructional technology applications. These evidenced-based practices will continue to be refined by teachers and staff to ensure students' needs are being met. In addition, we will monitor and evaluate students' progress on the continuum of social, emotional, mental health, and academic needs. In some cases, students may exhibit multiple needs in a variety of areas and we will view student progress on both a micro level - analyzing the specific intervention's success and on a macro level, assessing the progress of the whole child, again in part using data from various sources.

- 5. The District will use funds to provide evidenced-based interventions through a variety of means. Through a multi-tiered system of support model, we may identify a variety of student needs such as reading, mathematics, and social-emotional. This may span all grade levels with a targeted focus on K-6. Using some of the research of Fisher as well as Mendling and Mather, we selected evidence-based practices to address identified student needs. Some of the interventions we may implement include a targeted student in-classroom support by specialists, an enhanced WIN (what I need time) during the school day, additional mental health counseling support inside of school, as well as support for general education teachers in identifying and addressing learning gaps. Expenditures on the FS-10 that are reflected in our response include one teacher assistant assigned to our K-2 students, one special education teacher assigned to our 4-6 students, one special education teacher assigned to our 9-12 resource students and one special education teacher assigned to a 9-12 self-contained classroom. Needs of students in grades 7 & 8 are addressed through programs supported by the district's general fund. Please note that responsibility to provide social and emotional support is incumbent on ALL district staff including teacher assistants and classroom teachers, not only counselors and school psychologists.

The District will use funds to support evidence-based strategies to meet students' social, emotional, mental health and academic needs through a collaborative arrangement with the County of Onondaga to provide social worker services. The social worker services include programs designed to reduce student anxiety, and to develop curriculum development pertaining to social-emotional learning, and to implement staff development programs centered around improving students' social, emotional, mental health and academic needs.

Section 2001(i)(1) of the ARP Act requires each LEA that receives ARP ESSER funds to develop and make publicly available on the LEA's website, not later than 30 days after receiving ARP ESSER funds, a plan for the safe return to in-person instruction and continuity of services for all schools, including those that have already returned to in-person instruction.
