#### Talk Sup Week 29 Review and Preview

April 8, 2024

Good morning Sayreville! I hope you had a relaxing and enjoyable holiday weekend. Welcome to another edition of Talk Sup, my weekly newsletter. Please remember that **our schools will be <u>closed</u>** this Wednesday, **April 10<sup>th</sup>** in observance of Eid al-Fitr.



As you know, for the first time since 2017, there will be a complete solar eclipse later today at about 3:30 pm. According to physicians and astronomers alike, there is only one safe way to look directly at the sun, whether during an eclipse or not, and that is through **special-purpose solar filters**. These solar filters are used in **eclipse glasses or in hand-held solar viewers**. In fact,

physicians warn that **if you look directly at an** eclipse without the solar filtered glasses or viewers, your pupils will expand to

accommodate for low light even though the ultraviolet radiation from the sun remains high, which can cause **permanent damage to the cornea and retina of the eye**. Fortunately, thanks to the incredibly generous donation of a Wilson School parent, we will be providing solar filtered glasses or viewers to all our students in the elementary school, including Samsel, and



the middle school. Therefore, please remind our students to use their solar filtered glasses or viewers before looking at the eclipse.

As you probably know, **Thursday, April 25, 2024**, is designated as "**Bring Your Child to Work Day**." This activity is in conjunction with the national observance of "Take Our Daughters and Sons to Work Day" and is designed to help children ages **8-18** explore the workforce. Therefore, we anticipate that some of our students will be accompanying their parents/guardians to work on this day. Likewise, we anticipate that staff members will be taking their children to work for the same reasons. As we have done in the past, the parents of our students aged 8-18 that wish for their child(ren) to participate in this event at their place of employment and for them to receive credit for attending school, will be required to have their employer complete a form indicating their child(ren)'s participation and return it to their child(ren)'s school by **Tuesday, April 23, 2024**. If they have not already shared it with you, **contact your child(ren)'s principal for the form**. Similarly, staff members who wish to take their child(ren) aged 8-18 to school will also need to complete a form and submit it to their immediate supervisor and/or building principal by April 25<sup>th</sup>. **Staff should also contact their principal for the this form if it has not already been provided**. Our hope is that our students and the children of our staff members will benefit from the experience of "Bring Your Child to Work Day" and enjoy spending time with a parent/guardian in their workplace.

one to read them. In addition, this week each individual school's report will be posted on their respective websites. If you are not aware of it, the School Performance Reports reflect the New Jersey Department of Education's (NJDOE) commitment to providing parents, students, and school communities with a large variety of information about each school and district. These reports can be used as a tool to help evaluate whether all students have equitable access to high quality education. The NJDOE encourages you to use these reports to:

- Learn more about your school and district.
- Start conversations with school community members and ask questions.
- **Engage** with school communities to identify what schools are doing well and where they can improve.

The 2022-2023 School Performance Reports include all data that was previously reported prior to the COVID-19 pandemic, which includes all assessment, student growth, and accountability data. The NJDOE believes that it is critical to use the data in the reports, along with other information collected directly within districts and communities, to start conversations, identify gaps in information, and continue to find ways to ensure all students receive the support and resources that they need. The School Performance Reports can and should be used in conjunction with available school and district data to identify priorities for upcoming year planning and the use of state and federal dollars. As data over the last three years was impacted by the pandemic in various ways, the NJDOE does recommend caution in comparing data from year to year.

The 2022-2023 School Performance Reports include changes that respond to stakeholder feedback, federal and state requirements, and data availability. These changes include:

- **Student growth data** as measured by median student growth percentile for the first time since the 2018-2019 reports;
- Expanded **computer science course participation data** showing participation for all grades kindergarten through 12; and
- Results from the fall 2023 Every Student Succeeds Act (ESSA) accountability process.



If you did not have a chance to attend the Special "Let the Children Lead" BOE Business Meeting held on Tuesday, April 2<sup>nd</sup>, here is what you missed. During this

meeting, the Board of Education (BOE) and Central Administration were joined by almost two dozen 5<sup>th</sup> graders from the Samsel Upper Elementary School (SUES) as part of the annual "Let the Children Lead" program. During this very popular and unique activity, the selected 5<sup>th</sup> grade students actually performed in the

capacity of a specific board of education member or administrators. Thus, except for a few occasions, the 5<sup>th</sup> grade representatives for each, including Ms.

Coglianese, Principal of SUES, and Mr. Tola, Assistant Principal of SUES, voted and commented publicly on behalf of the BOE member or administrator that they represented.



The Board then moved the action items from the Superintendent's Report onto the Board Agenda and approved them all. To see the Agenda, click <u>here</u>. To see all attachments, click <u>here</u>. Among other motions, on the Vision 2030 Finance and Infrastructure portion of the agenda, the BOE approved the acceptance of a grant from the Middlesex County Office of Culture and Heritage in the amount of \$2,000 to be used for transportation costs for the SUES field trip to East Jersey Old Town and Cornelius Low House Museum. It also approve structured learning experiences for several high school students

participating in the STEM Capstone Externship program for the remainder of the 2023-2024 School Year in accordance with the conditions established by the NJDOE Structured Learning Experience Agreement.

On the Student Achievement portion of the agenda, among other motions, the BOE approved the long-term suspension of a student. Likewise, on the Governance portion of the agenda, the Board approved revisions to Board of Education <u>Policy 5570 Sportsmanship</u> and <u>Policy</u> and <u>Regulation 8660 Student</u> <u>Transportation</u> for a First Reading. To review them, click on each.

On the Personnel portion of the agenda, as well as other motions, the Board of Education appointed new certificated and non-certificated substitutes for the 2023-24 school year. Likewise, the Board appoint staff for the SUES STEAM clubs which will run from April 8, 2024 through Jume 12, 2024.

During the Board Discussion portion of the meeting, Mr. Smith reviewed what was discussed during the last Finance and Infrastructure Committee Meeting, as did Mrs. Pieloch for the last Personnel Committee Meeting. Likewise, Mr. Callahan reviewed what was discussed during the last Student Achievement Committee Meeting, as did Mrs. Napolitano for the last Governance Committee Meeting. Mrs. Bloom also shared news from the Middlesex County School Boards Association. Finally, each student representative shared their recommendations for this year's 3<sup>rd</sup> graders on how to navigate the successful transition to the upper elementary school.

The next meeting will take place at 7:30 pm on Tuesday, April 16<sup>th</sup> in the SUES Board Room. The agenda for this meeting will be posted on the district website on April 12<sup>th</sup>. A complete copy of the April 2<sup>nd</sup> Business Meeting minutes will be posted on the BOE Meeting Minutes page of the website once they are approved by the BOE during the next BOE Meeting on April 16, 2024.



This past week, our students, staff, alumni, and community members continued to impress us with their


