The 2012 Assessment shall be \$42,090; the 2013 Assessment shall be \$42,257; the 2014 Assessment shall be \$45,486. The Town Assessor shall execute a Certificate of Correction and the Town Tax Collector to adjust each respective grand list year and refund Janaki Corporation, Inc. the total amount due of \$16,441.07 without interest applied.
